

# NOTICE OF DETERMINATION CORE PARTICIPANT APPLICATION MODULE 1 - MR EDWIN POOTS MLA

### Introduction

- 1. In my Opening Statement on 21 July 2022, I explained that Modules would be announced and opened in sequence, with those wishing to take a formal role in the Inquiry invited to apply to become Core Participants for each module. On the same day, the Inquiry opened Module 1 and invited anyone who wished to be considered as a Core Participant to that Module to submit an application in writing to the Solicitor to the Inquiry by 16 August 2022.
- The <u>Provisional Outline of Scope</u> for Module 1 provides that this module will examine
  the resilience and preparedness of the United Kingdom for a Coronavirus pandemic.
  Further modules will be announced and opened in due course, to address other
  aspects of the Inquiry's Terms of Reference.
- 3. On 12 August 2022 the Inquiry received an application from Mr Edwin Poots MLA ("the Applicant") for Core Participant status in Module 1.
- 4. I made a provisional decision not to designate the Applicant as a Core Participant in Module 1, thereby declining the application ("the Provisional Decision"), on 7 September 2022. The Applicant was provided with an opportunity to renew the application in writing by 4pm on 16 September 2022.
- 5. The Applicant did not renew the application by the prescribed deadline. Accordingly, this Notice sets out my final decision on the application.



### **Application**

- 6. Applications for Core Participant status are considered in accordance with Rule 5 of the Inquiry Rules 2006, which provides:
  - 5.—(1) The chairman may designate a person as a core participant at any time during the course of the inquiry, provided that person consents to being so designated.
  - (2) In deciding whether to designate a person as a core participant, the chairman must in particular consider whether—
    - (a) the person played, or may have played, a direct and significant role in relation to the matters to which the inquiry relates;
    - (b) the person has a significant interest in an important aspect of the matters to which the inquiry relates; or
    - (c) the person may be subject to explicit or significant criticism during the inquiry proceedings or in the report, or in any interim report.
  - (3) A person ceases to be a core participant on—
    - (a) the date specified by the chairman in writing; or
    - (b) the end of the inquiry.
- 7. In accordance with the approach set out in my Opening Statement and the Inquiry's <u>Core Participant Protocol</u>, I have considered whether the application fulfils the requirements of Rule 5(2) in relation to the issues set out in the Provisional Outline of Scope for Module 1.

# **Summary of Application**

8. The application is put on the basis that Mr Poots was involved at various stages and in various ways in the government of Northern Ireland, including as Minister of Agriculture, Environment, and Rural Affairs from 11 January 2020 to 2 February 2021 and 8 March 2021 to present, Minister of Health, Social Services and Public Safety from 16 May 2011 to 23 September 2014, Minister of the Environment from 3 July 2009 to 4 May 2011, Minister of Culture, Arts and Leisure from 14 May 2007 to 9 June 2008



and Member of Ad Hoc Committee on the COVID-19 Response from 31 March 2020 to 7 March 2022.

- 9. The application says that given the breadth of the scope of the Inquiry and the likelihood that a wide panoply of government departments would have been required to take steps to prepare for a pandemic, it is envisaged that Mr Poots played, or may have played, a direct and significant role in relation to the matters to which the Outline of Scope for Module 1 relates for the purposes of satisfying Rule 5(2)(a). The application also suggests that Mr Poots satisfies Rule 5(2)(a) on the basis that, following the return of the Northern Ireland Executive after a three year hiatus in January 2020, he will no doubt have played a significant role in assessing and addressing the state of preparedness of his respective Department at that stage, as it tackled the myriad issues that developed as the pandemic took hold. Mr Poots' current role as a Minister is also cited as relevant in the context of planning for future pandemics.
- 10. The application also suggests that Ministers overseeing Departments in which key decisions on preparedness may have been made prior to 2020 may be subject to explicit or significant criticism during the inquiry proceedings or in the report, or in any interim report, for Module 1 for the purposes of satisfying Rule 5(2)(c).

## **Decision for the Applicant**

11. I have considered with great care everything that is said in the application. Having done so, I have decided, in my discretion, not to designate Mr Poots as a Core Participant in Module 1. Whilst I appreciate Mr Poots has had various roles in the government of Northern Ireland, there are a number of departments of the Northern Ireland Executive which will have had a more significant institutional involvement in relation to the matters to which the Outline of Scope for Module 1 relates, to whom I have granted Core Participant status. Furthermore, some of Mr Poots' roles



commenced from 11 January 2020 onwards, whereas the focus of Module 1 is on the resilience and preparedness of the UK, including Northern Ireland, before that time. I therefore do not consider that Poots' application meets the criteria set out in Rule 5 for designation as a Core Participant in Module 1.

- 12. In my Opening Statement I noted that I will publish more information about the issues intended to be covered by later modules in the coming months. Mr Poots may wish to consider applying for Core Participant status in relation to future modules likely to deal more directly with Northern Ireland's response to the Covid-19 pandemic.
- 13. It is also not necessary for an individual or organisation to be a Core Participant in order to provide evidence to the Inquiry. The Applicant may have relevant information to give in relation to matters being examined in the Inquiry and the Inquiry will be reaching out in due course to a range of individuals, organisations and bodies to seek information, to gain their perspective on the issues raised in the modules and, where appropriate, to ask for witness statements and documents.
- 14. For all of those reasons, having considered all of the information provided by Mr Poots in light of the Provisional Outline of Scope for Module 1, I consider that Mr Poots did not play a direct and significant role in relation to the matters sought to be investigated in Module 1, nor does Mr Poots have a significant interest in an important aspect of the matters to which Module 1 relates. I have therefore decided that Mr Poots should not be designated as a Core Participant in Module 1 and I confirm that this is my final decision.
- 15. I will keep the scope of Module 1 under review. My decision not to designate Mr Poots as a Core Participant in Module 1 does not preclude Mr Poots from making any further applications in respect of any later modules. I will consider any future applications Mr Poots may wish to make on their merits at the time they are made.
