Pandemic Flu Readiness Board

Work programme forward look – second half of year 2

Introduction:

1. Year 2 of the Pandemic Flu Readiness Board (PFRB) work programme is due to conclude in approximately 4 months. This paper outlines the proposed work plan and timeline for the completion of PFRB work streams.

Background:

- 2. In March 2018, the work programme for Year 2 of PFRB was agreed and Ministers were updated. This included the completion of a number of year 1 work streams and some additional work streams (Annex A).
- 3. Several year 1 work streams have continued into year 2, and progress on beginning some year two work streams have been delayed due to resourcing pressures and EU Exit work.
- 4. Nonetheless, it is important that the UK continues to improve preparedness for key risks, including Pandemic Flu. Additionally it is important that the Board meets our commitments to NSC (THRC).

Completed/Mainstreamed work streams

- 5. Work stream 1: Surge and Triage
 The CMO briefing paper has been finalised and agreed. NHS England are
 working to incorporate this into their service facing guidance.

 NOTE: the Devolved Administrations continue to work on this work stream.
- 6. Work stream 4: Sector Resilience
 All departments have completed their statements of preparedness. For Critical
 National Infrastructure (CNI), CCS are looking to incorporate this into
 quarterly reporting. For non-CNI sectors, work is underway to mainstream the
 work into departments. Business engagement continues.

Proposed work programme

- 7. Whilst it is important to continue to develop our preparedness for pandemic flu, a realistic approach has been taken to decide priorities and timelines for the next 6 months.
- 8. PFRB will continue to meet every 6 -8 weeks until the key outputs have been delivered. This will then be reviewed in March 2019.
- 9. The following work streams have been identified as a priority to complete in the upcoming months:

Work stream to delay / pause

- 10.A small number of work streams will need to be paused whilst resources focus on completing the above priorities. This will be reviewed in March 2019. These are:
 - a. WS 5 Ministerial clearance of the Four Nations Public Health Communications Strategy: the strategy has been revised and agreed by 4 CMOs and DA partners. As an internal-only document it is not

- considered critical that this receives Ministerial clearance before March 2019.
- b. Year 2 Cross-Government communications messages: DHSC and CCS Comms were to commission and coordinate public messages from OGDs. This work has not begun.
- c. Year 2 Pandemic Flu Resilience Standard: The final draft of the Pandemic Flu resilience Standard is currently out for consultation with LRFs. Dependant on the response to the consultation, publication may be paused.
- d. Year 2 Public facing guidance reconfiguration: An outline of the proposed restructure for is being presented at this meeting. Dependant on CCS resource, the technical reconfiguration and uploading to Resilience Direct may need to be paused until testing of the Resilience Direct system is complete.
- e. Business Checklist communication: The draft checklist has been produced. Work on sharing this with businesses has been paused, recognising other key communications about risks and contingency planning currently ongoing.
