CCS activity prioritisation

- Following Cabinet agreement in December we are prioritising no deal preparations from now on. This may include standing up Command, Control and Coordination arrangements for as long as required.
- CCS will continue a small number of essential activities alongside no deal preparations but have paused all other activity to enable sufficient focus on preparations for leaving the EU without a deal.

Yellowhammer preparations including governance, assurance of preparedness and exercising Statutory obligations including FOI requests and Parliamentary correspondence and obligations

Operational response and recovery capacity concurrent with no-deal preparations (see slide 5)

COBR development including infrastructure and technical upgrades

Foreign Direct Investment casework

National Security Risk Assessment (NSRA) completion

| Ebola Outbreak – Democratic Republic of the Congo (DRC) Number of cases: 627 total (579 confirmed & 48 probable) on 09/01/2019. However, this number reflects only cases detected and reported by the response, which has been seriously compromised in recent days due to unrest related to the election. This is now the second largest Ebola outbreak in history. | WHO's risk assessment: Regional – very high; National – very high; Global – low. Public Health England assess the risk for the UK population as negligible-very low. | DFID are leading the HMG response. They judge that the response in DRC is doing all the right things in very challenging circumstances, though it is not yet ahead of the transmission chain. The UK is contributing £43.6 million, in addition to sending experts from Public Health England and armoured cars from the CHASE stockpile. There is a good level of domestic preparedness. | DfID continue to monitor the situation. CCS are working with MOD, FCO and DHSC to update the existing MEDEVAC protocol to be suitable for Rwanda, Uganda and South Sudan. |
