# **Section 21 Inquiries Act 2005**

### Varied Notice requiring the Cabinet Office to provide evidence to the UK Covid-19 Inquiry

I hereby give notice under section 21(2)(b) of the Inquiries Act 2005 that the Cabinet Office is required to produce to the UK Covid-19 Inquiry, all materials listed in Annex A(i) and (ii) to this Notice. For the avoidance of any doubt, this Notice is issued on the basis that I consider the entire contents of the documents listed in Annex A(i) and (ii) to be potentially relevant to the lines of investigation being pursued by the UK Covid-19 Inquiry.

The Cabinet Office is required to supply these materials to the UK Covid-19 Inquiry by the dates set out within Annex A(i) and (ii).

Failure to comply with this Notice without reasonable excuse is, pursuant to section 35 of the Inquiries Act 2005 a criminal offence, punishable on summary conviction with a fine not exceeding £1,000 and/or imprisonment for a maximum of 51 weeks.

However, if the Cabinet Office claims that it is unable to comply with the Notice, or that it is unreasonable in all the circumstances for the Cabinet Office to do so, it may apply to me, pursuant to section 21(4) of the Inquiries Act 2005, for revocation or variation of the Notice. If it wishes to make such a claim, such written representations should be made to me by the dates set out within Annex A(i) and (ii), setting out all the matters on which it relies.

Following an application made under section 21(4) of the 2005 Act, this notice is varied to exclude from its scope the documents listed in Annex A to my Ruling dated 15 September 2023.

  - a. Comprise messages in a group chat established, or used for the purpose of communicating about the UK Government's response to Covid-19 ("group messages"); or
  - b. Were exchanged with any of the individuals listed in Annex B ("individual threads").
- 2. Unredacted WhatsApp communications dated between 1 January 2020 and 24 February 2022 which are recorded on device(s) owned / used by the former Prime Minister, **The Rt Hon Boris Johnson MP** and which:
  - a. Comprise messages in a group chat established, or used for the purpose of communicating about the UK Government's response to Covid-19 ("group messages"); or
  - b. Were exchanged with any of the individuals listed in Annex B ("individual threads").
- 3. Unredacted diaries for the former Prime Minister, **The Rt Hon Boris Johnson MP** covering the period 1 January 2020 to 24 February 2022.

If the Cabinet Office claims that it is unable to comply with the requirements of Annex A(i) to the Notice, or that it is unreasonable in all the circumstances for the Cabinet Office to do so, it may apply to me, pursuant to section 21(4) of the Inquiries Act 2005, for revocation or variation of the Notice. If the Cabinet Office wishes to make such a claim, such written representations should be made to me by **4pm on 9 May 2023**, setting out all the matters on which it relies.

# Annex A(ii) to the s.21 Notice issued to the Cabinet Office on 28 April 2023

The following are required to be disclosed to the UK Covid-19 Inquiry by **4pm on 29 May 2023**:

 Copies of the 24 notebooks containing contemporaneous notes made by the former Prime Minister, The Rt Hon Boris Johnson MP during the period 1 January 2020 to 24 February 2022. These notebooks are to be provided in clean unredacted form, save only for any redactions applied for reasons of national security sensitivity.

If the Cabinet Office claims that it is unable to comply with the requirements of Annex A(ii) to the Notice, or that it is unreasonable in all the circumstances for the Cabinet Office to do so, it may apply to me, pursuant to section 21(4) of the Inquiries Act 2005, for revocation or variation of the Notice. If the Cabinet Office wishes to make such a claim, such written representations should be made to me by **4pm on 15 May 2023**, setting out all the matters on which it relies.
