
# **Easy Read**

This includes the way the Inquiry:


• Collects and looks after information.

# Collecting and looking after information



The Inquiry collects information from different people and organisations that are involved in the Inquiry.



We follow the law about how to use and keep the information in the right way.



#### **Every Story Matters**

**Every Story Matters** is a listening project for people to speak up about what Covid-19 was like for them.



People who share their experiences through Every Story Matters do not give personal information, like their names.



The Inquiry is only collecting information about what happened to people, not who the people are.



This information will then be used to write a report about the most common things that happened during Covid-19.

All post and emails will be checked and anything important will be passed to the Inquiry's legal team.



#### Requests to witnesses

**Witnesses** are people who have important information that is helpful to the Inquiry.



When witnesses describe the information they have it is called a 'statement'.



The Inquiry needs witnesses to put their statements in writing so that they can be used as proof of what happened.



When the Inquiry asks witnesses for a written statement, or for more information about their statement, it is called a 'Rule 9 request'.



A **Rule 9 request** is one of the official rules that all Inquiries have to follow. The rules were set up in 2006.

## Children and young people



The Inquiry wants to hear from more children and young people about what Covid-19 was like for them.



We are setting up a new listening project, like Every Story Matters, that will just be for children and young people.



The information we collect from this new project will help the Inquiry understand more about:

• What happened during Covid-19.



What needs to change in the future.

#### Module 2



The Inquiry's work is split into parts called **modules**.

These **modules** look at different things to do with what happened during Covid-19.



Module 1 is now done and we will be starting Module 2 on 3 October 2023.



Module 2 is about all about decisions made during Covid-19.



This Module will look at the decisions about Covid-19 made by:

• The UK government.



• Government staff.



• Governments in Scotland, Wales and Northern Ireland.



• Local councils.

# **Updates on the other Modules**



Module 3 is all about how Covid-19 affected the healthcare systems in the UK.

Autumn 2024

Public hearings for Module 3 will take place in autumn 2024.



Module 4 is all about how vaccines and other treatments helped to deal with Covid-19.

Summer 2024

Public hearings for Module 4 will take place in Summer 2024.

## **Every Story Matters events**



We have started our community events where people in local areas can meet together and share what Covid-19 was like for them.

10 - 13 September 2023

The first community events took place in Liverpool between 10 and 13 September.

30 September 2023

The next community event is in Belfast on 30 September.



This will be part of a conference called the 'Northern Ireland Covid-19 Bereaved Families for Justice Conference'.




The conference supports people who have a family member who died during Covid-19.
