As an umbrella body, our views are based on the information which has been provided to us to inform our reports and publications referenced above. In particular, we would wish to draw your attention to our two joint responses to the Senedd Committee inquiry, and our two reports on the impact and legacy of COVID published in June 2020 and May 2022
- (iii) Whether the organisation or body raised any concerns about the consideration being given to the group(s) which it supports or represents with (i) the UK Government; and/or (ii) the Welsh Government, when those governments were making decisions about their response to Covid-19. - (ii) Our advisory role to Welsh Government's external stakeholder groups (question 3) involved giving consideration to the steps they were taking in response to the pandemic and ensuring that any the issues emerging from our service or research were shared through the meetings. Each of the meetings were coordinated and led by Welsh Government and minutes from those meetings will be available from the relevant officials.

The issues we would have drawn the Welsh Governments attention to are captured in our response to the Senedd Committee inquiry and our two reports on the impact and legacy of COVID, and would have included

Additional pressures on children and young people due to their experience of schools, childcare settings, youth clubs, primary health care and family support services experiencing periods of closure or had their services severely disrupted

- How pre-existing inequalities had been exacerbate, and raised particular fears around children's mental health, wellbeing and education; of children being exposed to violence in the home and increased poverty, and of the effects of experiencing trauma and distress due to isolation, separation and possible loss
- > Barriers for some children in respect of digital exclusion and associated costs
- > Impact of the pandemic on public and third sector services

As Children in Wales does not provide direct frontline services to the public, much of our evidence was drawn from correspondence with member organisations, some of whom, were also members of these Groups.
