UK Covid-19 Inquiry: Module 2 – Request to Long Covid Kids M2/R9R/LCK/TJS

We set out our responses to the Inquiry's request for information below. We have prepared our responses without sight and substantial consideration of the relevant evidence or disclosure. However, in order to assist the Inquiry as much as possible, we have tried to respond to the Inquiry's requests as comprehensively as we could at this early stage. This response is correct to the best of our knowledge given that the organisation was set up by patients who were extremely unwell at the time, many of whom continue to have ongoing health issues. It is provisional information provided without disclosure and to that end we reserve our right to amend or provide further information as necessary.

We would of course be willing to provide a statement to the Inquiry on the issues raised in the Inquiry's Rule 9 questionnaire in more detail.

A brief overview of the history, legal status and aims of the organisation or body. Please explain whether the work of the organisation or body is UK wide, or is instead confined to England, Scotland, Wales or Northern Ireland only. ¹

Long Covid Kids (LCK) was founded in September 2020 by people living with Long Covid. In 2021, LCK became the first registered charity advocating for families, children and young people living with Long Covid anywhere in the world. Currently supporting over 11,000 families, LCK's vision is to achieve recognition, support and recovery for Long Covid and related illnesses in children and young people. Our mission is to increase understanding, aid early diagnosis and improve response and intervention. LCK volunteers have worked tirelessly to raise awareness and effect change throughout the pandemic. Our Annual Report 2021-2022 spotlights our impact.

LCK's award-winning guidebook 'Shining a light on Long Covid in Children. A Guide to Recognition. Support. Recovery was created in response to the increase in demand for our support services. The guide contains practical and helpful information for health and education professionals, and families, designed to support and inform on recovery alongside our popular resources; Pacing Penguins and Cautious Tortoise.

Long Covid Kids is a UK-based international charity. Our headquarters are located in England and we have representatives in Scotland, Wales, Northern Ireland, the Republic of Ireland Europe, Greece, Argentina, the USA, Canada and New Zealand.

In terms of legal status, LCK is a registered charity in England and Wales. LCK is in the process of registering for charitable status in Scotland and is at the final stages of the process.²

2. A brief description of the group(s) which the organisation or body supports or Represents.

We support, represent and advocate for children and young people living with the ongoing symptoms of COVID-19 / Long Covid. This includes the families/caregivers and education and health professionals working with them. We support young carers of parents living with Long Covid. LCK is currently supporting over 11,000 families.

3. A brief overview of the work of the organisation or body in supporting or representing the relevant group(s) between January 2020 and Spring 2022 as it relates to the response to Covid-19 of (a) the UK Government; (b) the Scottish Government; (c) the Welsh Government; and/or (d) the Northern Ireland Executive.

We have set out at Appendix 1 Chronology of the work of Long Covid Kids has undertaken between January 2020 to Spring 2022³. This sets out in broad outline the work of the organisation in supporting and representing children and young people living with Long Covid. It should be apparent from that work that in summary, Long Covid Kids has advocated on behalf of children and young people living with and families affected by Long Covid in the UK by:

- 1. Writing to the Prime Minister and relevant Government ministers and MPs;
- 2. Meeting with Government Ministers and MPs;
- 3. Participating in relevant taskforces and expert panels relevant to Long Covid;
- 4. Submitting evidence to the APPG
- 5. Collaboration with other relevant partners
- 6. Contributing to UK and international research;
- 7. Undertaking wider advocacy
- 8. Devolved nations (summary)

1. Writing to the Prime Minister, relevant Government ministers and MPs;

We have made many efforts to engage the government in the risk of Long Covid and infection harm to children.

In the lead up to the first parliamentary debate on Long Covid on 11 January 2021 LCK wrote to MPs raising concerns about infection rates and Long Covid in children and young people. On 23 December 2020 LCK (co-founder Sammie McFarland) wrote to Chris Loder MP sharing our film "Our unhappily ever after" and raising other matters including the need to count Long Covid in children and the hospitalisation rates for children with COVID-19. On 7 January 2021 LCK wrote to Layla Moran MP (led the APPG on Coronavirus) on 7 January 2021 stating that LCK represented over 400 children and "almost all the stories are the same" that was having inadequate healthcare support and response. As part of the Parents United Against Unsafe Schools campaign a briefing was provided to MPs. The briefing stated:

"A 70% more transmissible variant is now in play, and the prevalence of long-term symptoms and life-long disability being incurred by children and young people as the result of coronavirus infection is uncertain. Before attempting to widen the opening of schools, we recommend the government ensure:

- A significantly lower rate of infection within the population
- The development of safety measures such as class size limits to facilitate social distancing and the reduction of the risk of airborne transmission, based on published and appropriate scientific data
- That schools are provided with sufficient resources to enact the safety standards set out above"

The administrative decision-making around advice to schools is an important aspect of our work. LCK have prepared a schools pack and a Support guide.⁴ On 12 April 2021 with Safe Ed for All LCK wrote to then Secretary of State for Health and Social Care Matt Hancock raising concerns about risks and mitigation measures in schools. The letter requested a meeting and stated:

- "Schools Mitigation Measures Required URGENTLY
- Improved ventilation and monitoring in all classrooms to reduce the risk of SARS-CoV-2 airborne transmission
- Masks (multi-layer) mandated in secondary, encouraged in primary
- Social distancing in primary and secondary
- Remote learning / rotas to reduce the numbers in school classrooms
- Suspension of fines during the pandemic (as per Scotland & Wales)

Please do whatever you can to help the Department for Education understand that safety improvements are necessary"

On 4 May 2021 LCK wrote to the Secretary of State for Education NR (copied to Education Secretaries for the devolved administrations) about mitigation measures in schools. This was part of a campaign by Parents United. The letter stated:

"It is essential that the UK achieves effective suppression of COVID-19, and the safe reopening of schools plays an essential part in this. A further spike in infections following the current lockdown would pose a range of unacceptable risks, including:

- the proliferation of further variants, which threaten our reliance on current vaccines as a pathway out of the Covid crisis
- compounding the already abhorrent UK death toll, presently standing at around 114,000

- increased numbers of Long-Covid suffers, whose condition is poorly understood and may yet prove to cause permanent disability
- further prolonged lockdowns, harsh restrictions, economic decline, psychological damage, and harm to the education and well-being of children

The previous full reopening of schools in September contributed significantly to the current wave. Government data indicates that, when schools were fully open, school-aged children were twice as likely as the general population to be the index case within a household, with secondary school-aged students being 7 times more likely to be the index case."

On 9 July 2021 LCK wrote to the then Secretary of State for Health and Social Care Sajid Javid stating that "We urge you to consider the lived experience of children with Long Covid, and early evidence from researchers when creating policy. The health devastation of Long Covid on children is already impacting the workforce, creating poverty as parents lose their jobs while caring for children enduring unnecessary chronic health issues." We raised various concerns that there was no paediatric clinical definition for Long Covid and so our members reported having difficulties accessing help, requested that the list of acute symptoms be updated, that the government acknowledge children could get Long Covid and requested measures to minimise infection (reinstatement of face masks in schools and funding for CO2 monitors and HEPA filtration for schools.

In March 2022 LCK wrote to Layla Moran MP, Damien Hinds MP and Andrew Gwynne MP requesting their support for the scheduled visit of children and young people with Long Covid to the Prime Minister's office at 10 Downing street on 1 April 2022⁵.

On 1 April 2022 a cohort of children and young people with Long Covid delivered LCK's support guide to Downing Street (see "Long Covid: Children affected take fight to Downing Street). Each child represented 10,000 young people in this country who have been seriously impacted by the condition, and they had come from every corner of the UK with letters describing the toll this illness has taken on their lives.

The visit was planned in coordination with staff at Downing Street, so LCK had to provide the details of the children and adults attending and were given security passes. The children were assured that their individual letters would be received by the Prime Minister's office. Several of these children have been disabled by a 'mild' SARS-CoV-2 infection, to the extent that they must now use wheelchairs. The visit to Downing Street required significant effort. Unfortunately neither the Prime Minister nor anyone from his office met the children and their individual letters were not received.

By letter dated 1 April 2022 LCK briefly wrote to the Prime Minister providing him with the LCK support guide and calling for:

- Improved indoor air quality in education settings for prevention health and well being
- Equitable education for all
- High quality co produced pediatric research

The Department of Health and Social Care responded to the visit in a letter dated 1 June 2022 which implied that Long Covid was caused by mental health issues⁶. By letter dated 28 June

<u>2022</u> LCK wrote and explained why this was inappropriate and factually incorrect. On 6 September 2022 James Morris MP Parliamentary Under Secretary responded with an apology.

LCK raised concerns about Long Covid in children by email dated 2 November 2022 to Neil O'Brien Parliamentary Under Secretary for State for Primary Care and Public Health and a meeting was agreed (not yet taken place).

On 21 February 2022 issued a joint statement with LC SOS raising concerns about removing all Covid measures.

2. Meeting with Government Ministers and MPs;

From early 2021 members of LCK attended the Long Covid roundtables, initially chaired by Lord Bethell. At these meeting we raised concerns about the minimization of the risk of serious long term illness in children. LCK attended Ministerial Round Tables on Long Covid on 23 February 2021, 20 April 2021, 16 June 2021, 21 July 2021, 23 September 2021 and 7 December 2021.

LCK raised concerns at these meetings about the risk of Long Covid in children and young people and the experiences of our members. LCK recorded a blog post on 28 September 2021 which sets out the matters we <u>raised with Sajid Javid</u>, then Secretary of State for Health and Social Care. These were:

- "The symptom list on the NHS and Government websites need updating
- Masks must be reinstated in schools including primary schools
- <u>Statistics</u>: 31% of all cases are currently in ages 5-14 years olds. 80% of hospitalised children are admitted "due to" Covid. 60% of those have no underlying medical condition.
- Children are unable to obtain referrals to Long Covid hubs.
- Chris Whitty states that it is inevitable that unvaccinated children will catch Covid.
- <u>Prevention needs to be a focus</u>. We need mitigation measures in schools to protect NHS resources and the long term health of children and families.
- The average age of children in our Long Covid support group is 10 & this age group has no protection.
- There is no cure for Long Covid, prevention must be the focus. We need a child focused public awareness campaign."

LCK campaigns to reduce children's risk of infection with SARS-CoV-2 by providing information on infection harms and layers of protection available in order that parents and carers can make informed choices and risk assess for the benefit of the children that they care for and lobbies for adaptions to be made for affected young people in educational establishments.

Long Covid Kids has had meetings with MPs as set out below (please note some of the specific dates are not known as records were not kept). Members would raise concerns with LCK and LCK would advocate for them. At these meetings LCK raised the core issue of significance to

circumstances, the Government know that there are those who have found this period especially difficult for their mental health and wellbeing"

their members these were broadly raising awareness that children were getting sick with COVID-19 and not recovering, raising concerns about the range of symptoms children experience, lack of paediatric definition, the urgent need for health care support, the issues caused by children being on long term sick from school, lack of support and awareness in education settings, the impact on parents of being unable to work due to the need to look after chronically ill children, vaccines and calling for biomedical research.

3. Participating in relevant taskforces and expert panels relevant to Long Covid;

LCK was a member of the NHS Task force and some sub groups. LCK reported in these meetings the experiences of the children and families that we supported in terms of the devastating impact of Long Covid, the symptoms, difficulties accessing care and all the issues that we have raised publicly.

The families that LCK support found that, particularly in 2020 –2021, despite turning to GPs for help and existing medical knowledge of post-viral illness for the children they were often disbelieved or dismissed.

In the first year of the pandemic LCK had to demonstrate that children and young people also suffered from COVID-19 as there was little information that children and young people could suffer debilitating symptoms and Long Covid. LCK wrote to individual hospitals and to GPs. They would say that they had no information that children suffered from COVID-19. We spent the first year evidencing the impact of COVID-19 infection and Long Covid on children and young people using lived experiences.

On 2 November 2021 LCK <u>published a statement</u> raising concerns about the decision of the JCVI not to recommend vaccinations for children.

4. Submitting evidence to APPG

On 26 January 2021 Sammie McFarland, Fran Simpson and Charlie Mountford-Hill of LCK gave evidence to the APPG on Coronavirus which was relied upon in its report on Long Covid in March 2022 (see p.16, 18 and 19). At paragraphs 17 – 23 the APPG made findings and recommendations relevant to Long Covid in children. Notably the APPG found that the UK Government's COVID-19 Policy applicable to educational settings failed to adequately protect pupils from contracting COVID-19 and therefore resulted in their developing Long Covid (para 17). The APPG acknowledged the wide range of symptoms experienced by children (para 21); it found that the UK Government had failed to adequately acknowledge the prevalence of Long Covid among children (para 22) and that the UK had failed to establish specialized care pathways for children living with Long Covid (para 23).

5. Collaboration with other relevant partners

LCK work with partner ogranisations to keep the spotlight on Long Covid in children and young people.

One of our founders attended the first WHO meeting on Long Covid on 21 August 2020. LCK have <u>also worked</u> with the World Health Organisation on their expert panels, on the nature of COVID-19 and impact on children. As part of this work LCK shared concerns and issues raised by members of their support groups, their surveys on symptoms and other issues relating to Long Covid in children and young people.

LCK stakeholders for NICE and were involved in the consultation process for the NICE Long Covid Guidelines in December 2020.

Other examples of collaboration include presenting at the Education Psychologist Festival of Educational Psychology, POTS UK Long Covid Masterclass, Independent Sage session on 30 September 2022 on Mitigations and Education, Long Covid Physio International Forum, Catherine Peckham Symposium, the Royal College of Occupational Therapists, Network on Cognition, International Severe Acute Respiratory and Emerging Infection Consortium, National Voices webinar, International Webinar of Pediatricians.

6. Contributing to UK and international research

LCK collects and spotlights child-specific infection statistics and analysis for continuous accountability and clear reporting of the impact that SARS-CoV-2 infection has on children. LCK strongly believe child-centered research co-produced with lived experience has the best change of directly benefitting families, children and young people; and directing meaningful changes.

In October 2020 one of our co-founders published an article in the British Medical Journal "Counting Long Covid in Children." She stated "There is a need for clinicians, at primary and secondary care levels, to be alert and aware of the multisystem symptoms in children through rapid guidelines or continual professional development. There is also a need for parents to be aware that this may explain ongoing issues that may come and go in the aftermath of a covid-19 infection."

LCK are stakeholders on the NIHR Expert Group panel on Long Covid and contributed to the guidelines looking at what should be funded for research

LCK are collaborating with the University of Derby on researching long covid. LCK are working with Post Covid Condition Core Outcome Set in Children Study (PC-COS-C) which is an international collaboration led by Dr Daniel Munblit.

A list of the research that LCK has contributed to is included in Appendix 2. For example LCK developed an online platform to enable parents from all over the world to report their child's experience. The 'Long COVID Kids Rapid Survey 2' was designed as a follow-up to a pilot survey (that established quantity and type of symptoms) as a means to establish clusters of

symptoms rather than the full breadth of symptoms as well as the effects on the mental and physical health of the child as a result of long COVID. The survey was used in a peer reviewed publication in Future Medicine – Clinical Characteristics, activity levels and mental health problems in children with long coronavirus disease a survey of 150 children.

7. Undertaking wider advocacy

LCK undertakes wider advocacy to raise awareness about Long Covid in children and seek support and improvements for its members. As well as writing to schools directly we would send them our Schools Pack about risk of transmission in schools, mitigation measures to reduce transmission, how to understand Long Covid and how it presents in a child etc.

LCK also advocated for members in relation to individual members' issues with specific schools eg about how best to support a child with Long Covid.

It made a film in September 2020. The film "Our Unhappily Ever After" (October 2020) was put on YouTube https://www.youtube.com/watch?v=RiIambG8vs0 and shared on social media.

LCK wrote to the Children's Commissioner Rachel de Souza on 10 December 2021 inviting engagement with us and children affected by Long Covid inviting engagement with stakeholders relating to Long Covid.

8. Summary of Information relating to devolved nations.

LCK has not been granted CP status other than in relation to M2. It is applying for CP status in M2A (see below). It has support groups in Wales and Northern Ireland. It represents and supports families affected by Long Covid in the devolved nations.

Scotland

LCK has not yet been granted CP status in Module 2A. However we understand that application is being progressed by Thompson's solicitors. To avoid duplication of work and to best assist the C19 Inquiry Team a summary is provided in Appendix 4. This is short list of work undertaken in Scotland however a complete and comprehensive answer can be provided in due course upon being granted CP status in Module 2A.

Welsh Government

On 22 June 2022 LCK Kids wrote to the First Minister asking for insight into the Long Covid Expert Group that they have established for a pathway to treat children.

On 10 July 2022 LCK received a reply from the Health Secretary's department promising insight into the final pathway once it had been finalised.

On 2 July 2022 LCK representative for Wales Kate Davies wrote to the First Minister of Wales about the expert subgroup on Long Covid in children. On 19 July 2022 LCK received a letter

from Lois Hullen, Women and Children's Health Branch stating that once a final pathway was in place it would be shared with LCK.

Kate Davies LCK lead in Wales wrote to and met on 25 July 2022 the Education Secretary Jeremy Miles in his capacity as MS for Neath for him to hear the personal story of a child living with long Covid and issues relating to education in Wales.

October 10th 2022 LCK had a discussion with members for the Welsh Government Education department to discuss CO2 monitors in schools, work around improving ventilation, investment and guidance provided. Discussed removing barriers for accessing education, difficulty in accessing Welsh medium education assurances for parents related to fines

Northern Ireland Executive

On 1 April 2022 LCK met with Gavin Robinson MP to discuss the lack of Post-Covid Support for under 16s, lack of mitigation measures in schools and lack of testing.

The view of the organisation or body as to whether the group(s) it supports or represents was adequately considered when decisions about the response to Covid-19 were made by (a) the UK Government; (b) the Scottish Government; (c) the Welsh Government; and/or (d) the Northern Ireland Executive. Please also explain the reasons for the view expressed by the organisation or body in this respect.

We provide these comments to assist the Inquiry with our views which are formed on the basis of our experience and knowledge of events to date. However they are only preliminary comments provided without sight of disclosure or evidence. It is our view that the impact of Long Covid on children and young people was not adequately considered when making decisions about the response to Covid-19 by the UK Government. This applies equally to those children and young people who were already suffering from the condition and those who would potentially be infected in the future. We have come to this view taking into account the following non-exhaustive issues:

- 1. Long Covid Kids believe the risk of long term illness/disability in children and young people was not adequately considered by the UK government in its pandemic response (see Letter to Matt Hancock 12 April 2021, Letter to Sajid Javid 9 July 2021) including in regard to advice to schools and educational settings about transmission.
- 2. There appears to be have been a lack of planning for post acute sequalae despite long term conditions being evidenced in previous pandemics.
- 3. There was an apparent failure to produce a public awareness campaign for COVID in children, including COVID-19 and PIMS symptoms; Long Covid in children and COVID-19 outcomes for children. LCK believe that as a consequence, testing of children was not prioritised and the symptoms of covid-19 in children were missed (see APPG report).
- 4. The government's guidance on the list of symptoms for COVID-19 did not adequately reflect children's experience and was not updated in line with developing evidence (see evidence to APPG; symptom survey and article on clinical characteristics in children here).
- 5. There are concerns that the high levels of infections among children, particularly in Jan/Feb 2021 and Jan/Feb 2022 resulted in *Child COVID-19 hospital admissions, Long Covid, PIMS-TS cases and child deaths* (see briefing to MPs with Parents United January 2021).
- 6. To the best of our knowledge Paediatric Inflammatory Multi system syndrome (PIMS-TS⁸) data has never been publicly available in the UK or centrally recorded (PHE/UKHSA may hold the most complete set of it). We are aware of two separate methods of data collection,

- one through the orange card system filled out by pediatricians and the other through PICA net which records PICU admissions.
- 7. We are concerned that at the outset of the pandemic the Government advisors stated that that children were less likely to contract or transmit Covid-19, without as far as we are aware a conclusive evidential basis for this advice⁹. We are concerned that may have led to inadequate consideration in regard to mitigation measures in schools and inadequate information to parents and members of the public.
- 8. Vaccination lessens the risk of long COVID in adults and children. However, messaging around juvenile vaccine programmes has, in our view, been poor.

Long Covid Kids has advocated and raised concerns to the UK Government and others arising from our experiences as parents of children with Long Covid and on behalf of our members since the early days of the pandemic.

In summary the concerns raised included our concerns about the high level of infection rate in children, the lack of public information messaging about Long Covid, the obstacles our members and supporters reported in accessing appropriate treatment pathways for their very ill children, mitigation measures in schools and other such issues.

We have set out above at question 4 the particular advocacy that we draw attention to. Concerns were also raised in direct meetings. For example in a Roundtable meeting with Sajid Javid on 23 September 2021 we raised concerns that the symptom list on the NHS and Government website needed updating (it only had three symptoms rather than the known and well established multiple symptoms of Covid-19 as identified by the WHO and CDC); that masks should be reinstated in schools; our concerns about children being admitted to hospital with Covid-19 who had no underlying health condition; that children were not able to get referrals to Long Covid Clinics/hubs; that the CMO Chris Whitty had stated that it was inevitable that

unvaccinated children would catch Covid and that prevention must be the focus as there was no cure for Long Covid.

7. A brief summary of the views of the organisation or body as to any lessons, if any, that can be learned from any consideration which was given to the group(s) that the organisation or body supports or represents by (a) the UK Government; (b) the Scottish Government; (c) the Welsh Government; and/or (d) the Northern Ireland Executive when they were making decisions about their response to Covid-19.

We provide these comments to assist the Inquiry to focus its investigations however they are only preliminary comments provided without sight of disclosure or evidence. We will only be in a position to provide detailed submissions on lessons to be learned after receiving disclosure and hearing evidence adduced during the Inquiry. Our preliminary view is that the following lessons could be learnt

- Recognise the risk of chronic illness and disability
- To take children seriously: listen to patient experience and have a child centered approach to diagnosis
- Improve the system for dissemination of crucial health information of novel conditions
- Encourage engagement with parent support groups to ensure they keep up with what is happening on the ground to achieve the best outcomes for children.
- Provide support for parents who had to look after chronically ill children
- Clarify the bodies representative of children's best interests in a pandemic situation
- Assist education settings with mitigation measures
- Improve guidance, policy and deterrents to counter misinformation and disinformation.
