Sorry I didn't do this yesterday / earlier. Here are readouts of strategy meeting over the weekend and today's PM meeting.

## **Update on Sat Strategy Meeting**

- Attached is final plan in CO papers, which as you can see takes on all of our suggestions except gives options on non-essential retail (mid May-early June)
- At the meeting key points were:
- Announcement at the end of next week (likely Sunday now)
- Shift from the current stay at home messaging, to balance continued vigilance and gradual easing.
- O Deep dive to be set up to scrutinise the plan on work, including the guidance [likely Wed now]
- Plan would be presented as 'earliest possible dates' for re-opening conditional on data and enablers being in
- o Need more detailed work on how to operationalise the opening of schools from 1 June. Favoured re-opening some or all of primary rather than focusing on transition years. Look to do school openings in a phased way. [Work on this is already underway and Sean's team is working closely with DFE/CO]
- There will need to be an aspirational date for the earliest possible re-opening of non-essential retail. The date of 18 May was discussed but not agreed by all.
- We need much more detailed work on how to operationalise the transport requirements of this approach, which should be covered in this week's deep dive

So overall: we ended up in same place as our plan on open sectors and schools. But still some uncertainty/push back on non-essential retail. There is also a risk that PM concerns about TTT/testing/surveillance undermines our position. Also PPE as it is one of the five tests.

## Readout of this morning's PM Meeting

- Cx reiterated his message that any softening of the "HMT plan" bakes in hardship. Cx focused in on non-essential retail and hospitality:
- o CMO said that if we don't get things open by Sept, then given winter surge, will need to wait until September
- If this is the case for hospitality then this sector is "gone"

- Obviously when we say hospitality to open we mean in new/SD way.
- Therefore need hospitality open in Summer (July), and to his this and to stage things....this means open sectors now, schools early June, and non-essential between the two (mid may)
- Also will make school teachers feel better not to be first.
- PM acknowledged this point but said critical to improve plan on PPE/TTT/surveillance/care homes. It goes to public confidence. We had a long discussion about this. Revisiting responsibilities for TTT/surveillance (pls protect). See attached slides on surveillance.
- PM really keen to have a session on supply side reform in the context of recovery plans. Stuart likely to commission a deep dive in next few weeks.
