- My participation in SAGE SPI B Policing and Security Subgroup was limited to a relatively small number of meetings, focused on report-writing (all available online) and members received an email from the Secretariat on 28.6.21 to 'stand down' the group.
- 5. Your views as to any lessons that can be learned from the UK's response to the Covid-19 pandemic, in particular relating to the work of SAGE and/or its subcommittees.  - The UK response was not always aligned to the work and findings (as produced in reports) of SAGE and its subcommittees, either in terms of timeliness or in actuality. Furthermore, there was no single "UK response" since, from summer 2020, different approaches evolved across four nations of the UK. My most direct observation is that, according to *The Sunday Telegraph* at the time, the 'Stay Alert' slogan was devised by Isaac Levido and Ben Guerin, two social media strategists who advised the Conservatives during the 2019 election campaign, not the Government's scientific advisors. So the lesson learned is to leverage the expertise sought across all areas.
