Dear Inquiry Team,

Thanks for your reply. My response to the questionnaire follows:

This examined the relationship between ethnicity and outcome for patients with COVID-19 early in the pandemic. This was published subsequently in the medical journal BMJ Open (see https://bmjopen.bmj.com/ content/bmjopen/10/11/e042712.full.pdf).

However, as I understand that the questionnaire relates to my involvement with SAGE and its sub-groups, I have answered the questions raised by reference to that involvement only.

Thank you for contacting me regarding Module 2 of the UK COVID-19 Inquiry (Reference M2/SAGE/01/JB).

My role in relation to SAGE was very limited. I joined one meeting of SAGE by teleconference to present the results of an analysis that had been completed using data available to NHS Digital. This examined the relationship between ethnicity and outcome for patients with COVID-19 early in the pandemic. This was published subsequently in the medical journal BMJ Open (see https://bmjopen.bmj.com/content/bmjopen/10/11/e042712.full.pdf).

My participation was a direct consequence of the fact that I was, at that time, the Acting Chief Medical Officer of NHS Digital, rather than being an independent expert. However, it was not clear from your letter whether you were aware of the nature of my involvement and if not, whether this information may impact on the questions asked and who they are addressed to. I am keen to assist the Inquiry as best I can, but to enable me to do so, can you please clarify the capacity in which these questions are being asked of me (whether as Acting Chief Medical Officer at NHS Digital at that time or in a personal capacity)?

If it is the former, then questions about my involvement in SAGE may be better addressed via NHS Digital.
