There may be areas that fall within the remit of either the General Public Sector or the Healthcare Ministerial Implementation Group. These will be considered on a case-by-case basis.

To consider the impact of C-19 on NHS capacity, social care capacity, public health and other health and social care provisions and make decisions to drive the Government's response to that impact.

Long ToR for internal use

The Healthcare Ministerial Implementation Group will focus on:

- policy interventions to protect public health, including monitoring and implementation of current interventions, and consideration of any future interventions;

- the healthcare supply chain;
- the preparedness, capacity and functioning of the social care system and consider interventions needed to manage risk and support effective delivery of critical care;
- the assessment of intelligence and analysis on impacts on the NHS, public service providers, including with regard to future delay measures;
- the Government's public health communications strategy, and agree communications
 to the NHS, health sector and social care sector, as part of the central HMG
 communications strategy. It should consider and advise on each department's plan for
 contributing to public health, and engaging the NHS and public service providers;
- our crisis management and plans to respond to urgent health and social care developments, in collaboration with the SAGE Committee;
- the development and implementation of the package of medical and social support for those to whom we will be providing the shielding intervention, i.e. the 1.4m most clinically vulnerable.

As necessary, this Ministerial Implementation Group will escalate cross-cutting, strategic

decisions to COBR for collective decision making and/or the daily PM-chaired C-19 meeting for strategic steers.

The Healthcare Ministerial Implementation Group will meet on both an England-only and UK-wide basis, with Devolved Administration participation depending on the agenda for each meeting.

Long ToR for internal use

The International Ministerial Implementation Group will coordinate and advise on UK's role in the coordination and delivery of the international health and economic response to the C-19 pandemic, bilaterally and through multilateral (e.g. G7/20) and international (e.g. WHO, IMF, World Bank) organisations. Setting the UK's strategic approach to the threats and opportunities arising from the pandemic and setting the course for the longer term strategic national recovery. It will report to the PM-chaired daily C-19 meeting, and will meet as required to ensure a coherent approach to the international response. In particular the International Ministerial Implementation Group will consider:

- developing the next phase of the international response including consular issues when cross-government Ministerial decisions required;
- supporting the immediate global healthcare response including through a strong international narrative backing the WHO and an evidence based approach;
- supporting developing countries with the immediate global health response filling the funding gap for the response;
- leading the global economic response in support of UK prosperity- committing to coordinated action to ensure the shock is temporary;
- strengthening multilateral coordination of the global health and economic response;
- international travel restrictions and their social and industrial implications including the aviation sector;
- the lessons learnt from the pandemic to ensure that the global community is prepared for the next one; and
- to consider the UK's strategic response to national security threats and opportunities and long term recovery on the world stage.

The International Ministerial Implementation Group will not consider:

- specific consular issues that do not require cross-government coordination and which are within the FCO's competence; and
- domestic economic issues which fall within the scope of the CX led committee on the economic response.
