



Following a period of sustained downwards trend, there were 47 Inadequately Documented Arrivals on 26-Mar, the most in a single day since 15-Feb.




#### Managing new demand relating to COVID-19

The Call Centre set up in response to COVID-19 continues to see high email and telephone demand. Average queue to call time breached 2 hours for the second time on 30-Mar.



#### Sustaining critical business as usual operations

The number of death registrations have remained on trend since the emergence of COVID-19. This is because, to date, the number of deaths as a result of the virus accounts for a small proportion of the number of deaths that are recorded on a weekly basis. Deathbed marriage registrations have also stayed on trend.



Data included initially comes largely from existing routine reports collated centrally. We will expand and iterate the data/analysis accompanying the sitrep over the coming days to: Evaluate what further data is required and establish the data feeds to get that data added to the sitrep and; Assess the most appropriate frequency on which to update each data feed (as not all data is currently available on a daily basis, or is meaningful when updated at that frequently). Any feedback on priority areas to establish data feeds will also be taken into account.

## **Scientific Advisory Group for Emergencies**

SAGE met on 29 March 2020 and have advised as follows:

### Summary


- SAGE endorsed the reasonable worst case and optimistic scenarios, incorporating changes discussed in the meeting.
- Further work is required to understand how best to release measures and the scale of any resultant epidemic peaks.
- Further work is required on age distribution of ICU cases.

### Situation update

- The average length of stay in ICU was taken as 9.5 days on NHS advice.
- Vast majority of admissions to ICU and high dependency units are aged between mid 40s and 70. There are fewer
  admissions among the over 70s. ICU care may not reflect the full burden of disease, as now many patients are being cared
  for in other settings.
- NHS reported that critical care bed occupancy is not yet reaching saturation levels, London included.
- There is evidence that severity varies by sex (men are affected more severely), but there is no evidence that transmission varies by sex.
- NHS models use numbers approved by SAGE, but they are run more frequently and need to provide regional and other detail leading to quantitative, but not qualitative differences in projected scenarios.

### Reasonable worst case (RWC) and optimistic scenario

- SAGE noted that the underlying epidemiology is unchanged, but cases within the NHS have grown rapidly, affecting bed
  requirements. Some numbers contained in the scenarios derive from data; others are assumptions for example, around
  compliance. Age profile of ICU patients is not critical to modelling the trajectory of the epidemic but modelling will need to
  evolve to reflect emerging practice in referrals to ICU. The modelling draws on both admission and death data
- Further work is required to understand how best to release measures and the scale of the second epidemic peak. This is a priority for SAGE in the coming week.
- Further work is required on age distribution of ICU cases.



# Policing

- National Total Absence: 42,051 officers and staff representing 15.6% of national staffing on 30 March, up from 14.8% yesterday.
- 5 forces assess their current resource status as amber, a decrease of 2 since 30 March. 0 forces are assessed as red, 0 forces are assessed as black, 44 are assessed as green and 6 are assessed as blue.
- **5** forces have a total absence rate above 20%, no force has a total absence rate over 30%. No change.
- **8** forces are taking actions outside their core responsibilities, No change since 30 March.
- 0 forces have made Mutual Aid requests. No change.
- **7** forces have identified an issue with specialist capabilities. No change.
- 15 forces are experiencing disruption of delivery to standard force supplies, a decrease of 2 since 30 March.
- 7 forces face ongoing vulnerabilities in relation to Critical National Infrastructure in their area. No change.
- National Police Leads are reviewing the capability of forces to manage concurrent events (Bridges, riots or act of terrorism). There is likely to be significant challenges in the event of concurrency, if staff abstraction rates increase due to COVID-19, even accounting for the potential of military support.





# **Crime and Community Tensions**

### **Community Tensions:**


- There have been continuing reports received relating to neighbours reporting their neighbours for not following social distancing guidelines.
- There has been no new reporting regarding places of worship being open since the weekend.
- NPoCC has received reporting of a number of incidents involving persons with mental health issues who are struggling to cope with self-isolation restrictions leading to various altercations with family members.
- NPoCC continue to receive reporting of unessential travel to second homes, holiday lets and caravans

### Hate Crime:

- The Police National Community Tensions Team (NCTT) continue to observe a higher levels of offences targeting those of Chinese, Japanese or South East Asian heritage (IC5). A total of 78 offences targeting people of Chinese or perceived Chinese ethnicity were recorded in the period 13/03/2020 – 19/03/2020, an increase of 129% (44 offences) over the 34 offences recorded in the previous reporting period.
- Police analysis continues to identify some targeting of other ethnicities in relation to the use of 'coronavirus', There were 80 offences which were recorded to have utilised the term 'coronavirus'. Of these offences 30 targeted people of Chinese or perceived Chinese ethnicity (IC5), 20 were of other ethnicities and a total of 30 did not record the victims ethnicity. The NCTT assess there is likely to be under-reporting of hate crime incidents.

### Public Order:


- NPoCC note that several forces have provided returns noting a decrease in public order offences and increased compliance with police instruction by members of the public (declining volumes remain the overall reporting trend despite the overall number submitted to NPoCC today increasing compared with yesterday).
- The majority of public order incidents relating to COVID-19 continue to be linked to individuals and groups failing to adhere to social distancing restrictions, leading to public order incidents. Incidents include individuals who cough, sneeze and spit in victims faces, including Police Officers, other emergency workers, and retail staff. Reporting indicates that a number of individuals have been charged and sentenced in relation to these offences.



## **Office for Security and Counter-Terrorism**

OSCT update. (Note: It has been agreed that this will be provided weekly)

- The Counter Terror System is able to deliver all critical functions, although impact of school closures still being analysed.
- However, overseas CT crisis response significantly diminished.
- PREPARE functions under significant strain and ability to respond to a terrorist incident limited.




## **Serious and Organised Crime**

### Key Activities

- Child Sexual Abuse and Exploitation (CSAE) Increasing time online as a result of school closures and restrictions on movement may result in an increasing number of children being approached online by offenders. CSAE continues to be prioritised by the NCA.
- Fraud and Illicit Finance Fraudulent activities relating to COD-19 testing kits, and phishing attempts following the Government's SMS have been identified. The National Fraud Intelligence Bureau (NFIB) data for the past 72 hours reports that there were 73 new reports of COVID-19 related frauds. The (unverified) losses of the 73 COVID-19 related reports is c.£240k with one mandate fraud accounting for £105k.
- Borders Threat Due to the reduction in passenger numbers, Border Force will be diverting resource from other areas into unaccompanied freight and fast parcels. They are seeing a rise in unaccompanied freight due to drivers not wishing to cross borders or being unable to do so. Fast Parcel numbers have not decreased and are assessed as likely to be used more for moving illicit commodities.
- Commodities Illegal drug prices are rising nationally owing to restricted supply. The HO and NCA are meeting with key partners to share intelligence and understanding today, 31 March.
- Advice is with the Minister proposing that victims of modern slavery in safe houses are not made to leave for the next three months. This will have significant impact on ability to meet demand for safe house accommodation.
- Most non-UK modern slavery conclusive grounds decisions require access to paper files. Some solutions being sought via
  other information sources, but a point will be reached where conclusive grounds decisions will slow and WiP will rise. The SCA
  has referred approximately 125 new referrals this week instead of the usual 240-250.
- Work ongoing on prisoner release with HMPPS and law enforcement agencies to agree SOC cohort criteria
  of release exclusions and assurance. Other SOC work in prisons delayed as resources focus on COVID-19 response.


### National Crime Agency

- None of the NCA's critical capabilities are currently at risk due to staff absence.
- NCA are currently revising staffing figures due to on-boarding. Absence figures should be reported again tomorrow, 1 April.




## **Fire and Rescue Service**

- The national total number of personnel absent as a result of either COVID19 related sickness or self-isolation is 3815 as of 31 March which is a decrease of 212 from 30 March.
- Average total workforce absence across the responding services is **7.96%** a decrease of **0.22%** from 30 March.
- Majority of FRS are reporting supply chain issues, which may be exacerbated by approaches from ambulance services for PPE provisions, and supplier issues with breathing apparatus ancillaries.
- 3 FRS have reported a reduction in front line appliance availability due to COVID-19 impacts. This is unchanged since 30 March.
- No National Resilience assets have been declared unavailable as a direct result of COVID19 related impacts.
- BRAG ratings for FRS remain unchanged from 30 March: 37 green, 14 amber.
- States of Jersey Fire Service reported for first time.
- Some FRS are reporting increased availability of on-call firefighters.

## **Communications and Social Media**

#### Press / Media

- Police: Media scrutiny of the role of police in enforcing the coronavirus 'lockdown' continues, with reports that guidance has been issued by the National Police Chiefs' Council (NPCC) and College of Policing. The Guardian reports that forces are being warned not to over-reach their powers, while the Telegraph carries an op-ed from Metropolitan Police Assistant Commissioner Neil Basu in which he highlights the need to police by consent. Interviewed about these issues on the Today programme, NPCC chairman Martin Hewitt said a proportionate and consistent response was needed and noted that police were dealing with unprecedented measures.
- Safeguarding: Nicole Jacobs, Domestic Abuse Commissioner was on the Today programme this morning saying that more clarification is needed that people can leave their homes and seek support if they are at risk of domestic abuse, adding that the Home Secretary made that clear at the weekend. She added that there has been an increase in web traffic and calls to the national helpline, with women in particular seeking advice about child custody and concerns relating to debt. In separate coverage, several papers report that Billy Joe Saunders has had his boxing licence suspended following a social media post in which he seemingly advocated domestic violence. The Metro notes that Saunders apologised on social media for the video and intends to donate £25,000 to a domestic violence charity.
- Immigration: There was some coverage in the Guardian and trade press of the announcement yesterday to amend the Right to Rent and Right to Work checks for landlords and employers. The coverage was mostly straight, with the explanation that the temporary changes have been made in light of coronavirus.
  - Press Office continues to receive calls on immigration removal centres, including a query from the Guardian today on coronavirus cases at Tinsley House, Harmondsworth and Brook House and calls for detainees to be released. We are working with policy colleagues to agree updated lines.

#### **Digital**

- · Posting a rebuttal animation on assaults on emergency workers and protections in place.
- Amplifying content from OGDs specifically No10 and DHSC.
- · Posting NHS visa extension animation, if announced today.

#### Strat Comms


• We are feeding into the submission on CSA to outline the preventative communications that is happening or planned in this space, in line with the increasing threat. We are expecting to hear back on the Fraud note and are working with gov.uk as well as the key agencies on an agreed overarching narrative and comms plan.

#### **External Affairs**

- The External Affairs team will share the domestic abuse GOV.UK one pager with stakeholders today and ask them to amplify on their channels. Calls with NPCC and APCC to consider what work is being done on DA across the forces. The team are also continuing to work with policy and press colleagues on a CSE policy note.
- NPCC- BBC bids for 6s and 10s this evening for Martin Hewitt to speak about policing measures. They want to use this as an opportunity to reiterate that the police are taking a measured approach to this.
- College of Policing –looking to publish guidance for forces on COP website this afternoon (which went out to all forces on Thursday). This will include two documents, one around new regulation and the second with guidance specifically around the Act. They have also been approached by Sky News to speak on this evening's show about the guidance and what this means for the public.


## **Border Force**

### **Key Issues**

- A repatriation team within Nat Ops HQ are working closely with the FCO and across regions on incoming repatriation flights. The importance of the provision of accurate data is a particular concern and work is ongoing to assure this and the process.
- BF are feeding into new data products around what data they can provide and where it comes from (passengers, air traffic, sea traffic and freight amongst others); this will enable production of a regular 'single source of information'.
- BF refreshing the TTCG and working closely with intelligence colleagues to examine new and emerging threats and appropriate tasking.
- Updated Reasonable Worse Case Plan received from Civil Contingencies Secretariat will inform BF's own RWCS and resilience planning.
- Border Force has taken a phased approach to stepping down non-operational priority activity as staff have been
  redeployed to support the response to COVID-19. Those strategic functions with a Home Office or crossGovernment interdependency, or those which are supporting Home Secretary priorities will be protected as far
  as possible. Alongside these, Border Force will also seek to protect those activities for which the medium to long
  term impact of not proceeding is likely to be greater than the cost of ringfencing them now:
- BN dependents visa waiver requests 148 received as of 31 March.



## **Immigration Enforcement**

- There are no known/live cases of COVID-19 across the immigration removal estate, with manageable number in protective isolation (17)
- The quarantine in place at Colnbrook IRC was lifted on the afternoon of 30 March, but remains in place at Harmondsworth due to cases of flu. The Centre is due to re-open for admissions on 3 April, once a deep clean of the site has taken place.
- Daily reviews continue for any new vulnerable cases in detention to ensure 'Adults at Risk' levels are not
  increased due to the risk of COVID-19 on those with underlying health conditions. High levels of cases have
  been released or are in the process of being released, with caseloads being reviewed daily to ensure detention
  remains appropriate.
- Immigration Enforcement report 8 clandestine encounters, with 16 individuals encountered. Border Force report
   5 clandestine encounters, with 6 individuals encountered at the juxtaposed controls, and 2 encounters, of 5 individuals, in Zeebrugge.
- IE anticipate French law enforcement to be in the migrant camps on Tuesday seeking to move migrants on a voluntary basis to centres around France.
- At 31 March, IE have resolved issues with CMAC, the coach contract provider, who were unable to find a transport provider on 28 March for a symptomatic case (non-clandestine). IE have received assurances that transport will be available in the future.
- All reporting centres remain closed and reporting events cancelled.




- Director of Resettlement, Asylum, Support and Integration (RASI) has written to Public Health England to clarify
  public health advice that has been given to RASI in relation to the accommodation estate, specifically, the
  Initial Accommodation locations in Wakefield and Birmingham that house between 200-300 service users each.
  PHE advice has been to treat these locations as a 'shared household' and only those with symptoms should selfisolate in the facility. This differs from advice that local authorities have been given, where UKVI has been
  asked to take 194 people out of the facility in Wakefield. Meetings on this with PHE are taking place later today.
- Integration and Vulnerability are continuing to engage with the British Red Cross (BRC), as the single point of contact for the NGO sector. UKVI has three calls with them a week to update BRC on the latest HO position on resettlement/asylum issues. BRC welcomed the decision on asylum support made on Friday 27 March.
- FCO announcement on **plans for repatriation flights** clarification required on focus of the flights to assess likely impact on **existing compelling/compassionate visa process** & whether capacity increase required.
- Key supply lines haulage drivers transporting produce from outside EU Moroccan/Turkey & other visa
  national drivers. To be discussed with Border Force bronze on handling at the border for drivers with expired
  visas given disruption to VCS overseas visa service.
- **COVID-19 Call volume** was 238, down on the 351 received on 27 March. Call waiting time increased to 2 hours from 1 hour 36 on 27 March. Monday also saw a significant increase in the number of abandoned calls with over 1400 recorded.




# HM Passport Office (including General Register Office)

- HMPO Service Delivery are in early discussions to increase examination resource to manage work in progress levels to maintain reasonable performance against turnaround service level agreements. This requires analysis of demand, potential capacity and the constraints arising from providing a safe environment, in accordance with PHE advice, for staff to return to working in our sites. HMPO is also looking at how they can balance the passports requirement and also support the DWP ask.
- GRO are currently engaging with registration services that will have Nightingale Field Hospitals established within their local authority area (currently Newham, Birmingham and Manchester). These services will be dealing with an increased number of death registrations from these sites and will need to work closely with the hospitals to support the logistics of establishing new bereavement teams in each, suppling Medical Certificate Cause of Death certificates for doctors and setting up processes that will enable timely registration of deaths so bodies can be disposed.
- The local authorities impacted currently do not have sufficient staffing cover to deal with the anticipated volume of deaths from each field hospital. - GRO are engaging across regions to bring in support from surrounding local authorities to assist with this through partnership working.



## **BICS P&I**

- The daily **General Public Sector Ministerial Implementation Group** (GPSMIG), which was attended by the Home Secretary, included an item for discussion of a joint Home Office-DFT paper on border planning and resilience.
- The Home Secretary also attended the **International sub-committee meeting** where further updates on ventilators and repatriation were provided. It remains important to ensure that Border Force are involved in all repatriation efforts at an early stage. A paper on UK assistance to vulnerable countries was also presented. Further work on this is needed to ensure the scale of the irregular migration threat to the UK is considered.
- Temporary adjustments to right to work and right to rent checks were announced 30 March.
- NHS workers' 12 month visa extensions were announced midday 31 March.
- An information note on the capability and capacity within relevant UK operational partners related to law enforcement and judicial cooperation is going to the Home Sec 31 March as well as Immigration contingency proposals for Hong Kong British Nationals (Overseas) (BN(O)s) and their family dependents.
- Work continues at pace on advice to address the closure of in-country UK visa and citizenship application services (UKVCAS) and service support centres (SSC) due to COVID-19 on the most vulnerable/priority immigration cases.
- Questions have been raised by Heathrow colleagues regarding refusing entry to visitors coming to the UK which are deemed to be unnecessary travel under the UK's restrictions. Advice is being worked up on this issue.



# **HO Staffing**

### **National Security Vetting**

• NSV are reporting that they are currently operating at 15% capacity of BAU service level. We are urgently analysing the impact with HO security colleagues. It is likely we will need to prioritise recruitment activity accordingly to manage demand to NSV.

### **DWP** redeployment

 We are working with HMPO colleagues and considering the feasibility of the deploying HMPO and potentially UKVI staff to support DWP. There are a number of operating models being considered, including deployment of HMPO staff working in HMPO locations but completing DWP work or working from home. We need to be able prioritise HMPO activity alongside any deployment to DWP work.

### PHE advice on social distancing in an operational context

• We are working with PHE to understand what measures can be put in place to mitigate risk and ensure social distancing measures can be practically implemented notwith standing operational constraints

### Volunteering


• Likely that COVID 19 legislation enabling volunteering for NHS will not apply to crown servants. Initial perspective is that Civil Servants will not be able to volunteer during working hours beyond the existing allowance of special leave that can be used for volunteering. Awaiting advice on the position of Reservists.

### Key worker letters

• We are developing a process for issuing letters to Key Workers that can be used as evidence for the Police or other agencies to verify key worker status. We will issue guidance ASAP, it is likely to recommend DG and COVID response teams coordinate issuing them locally. They will need to be issued by G7 or above and records kept accordingly.

### **Mental Health & Bereavement**

- The 1<sup>st</sup> mental health Steering Board took place today and suggested development of a Bereavement policy.
- In the light of deaths in service that may be COVID 19 related we are assuring our policies and processes to ensure we have a
  holistic package of support available to line mangers and colleagues affected, recognising the sensitivities involved and
  respectful of the wishes of the immediate family.

- Further guidance on home working has been approved by HR and will be available on Horizon 1<sup>st</sup> April.
- Requests for the replenishment of hand sanitisers are being addressed by MMS on a priority basis and the Croydon supplies will be despatched this week.
- Requests for reasonable adjustment furniture and equipment are being dealt with on a case by case basis.
- **2MS** Bouygues have confirmed that they have sufficient resource to keep 2MS open no change.
- **Croydon** Lunar House remains open with guarding. Metro Point and Apollo House will remain open for staff with valid security passes no change.
- **Regional Offices** No new reported building closures. The level of occupancy in all buildings is less than 10%. The majority of buildings still appear to be open but restricted access to operational teams and departments delivering business critical activities.



### **Commercial:**




## **Annex C – Issues for UK Nationals Overseas**

### **Travel advice**

- FCO travel advice has been reviewed and standardised. Each country now has a 'Return to the UK' sub-page detailing options available.
- Following the Foreign Secretary's 30 March announcement that the FCO is partnering with airlines to fly back circa 50,000 British National tourists stranded abroad due to the COVID-19 pandemic, FCO is updating countryspecific travel advice with details of confirmed special flights and booking instructions.
- FCO continue to advise against all non-essential international travel. BNs resident in the UK who are currently travelling overseas are advised to return as soon as possible, while commercial options for return are still available.

### COVID-19 cases abroad

- 30 March, there were 55 new COVID-19 (not diagnosed) related cases, bringing the total to 618 cases. Spain continues, to have the highest number of cases, with India, Azerbaijan, Australia and China remaining in the top 5. Turkey, New Zealand, Ghana and USA all had high number of new cases on 30 March.
- COVID-19 related cases (positive diagnosed) from 30 March are 171 cases of British nationals with a positive COVID-19 diagnosis. New cases have been recorded in China +2, Italy +2, Spain +2, Australia +1, New Zealand +1, South Korea +1.






99.2% Non-EEA Passengers Cleared at the Border in SLA timescales nationally WE-20-Mar













### Total Records by Business Area





**Death registrations:** The number of death registrations have not spiked since the emergence of coronavirus in the UK; they have remained on trend. This is because, to date, the number of deaths as a result of the virus is small as a proportion of the number of deaths that are recorded on a weekly basis. Note that January is higher due to the delay in registering deaths over the Christmas and new year period as offices are closed due to Bank Holidays. The fourth week of January is spiked because it incorporates more days of data, longer than a week (from the 22<sup>nd</sup> to the 31<sup>st</sup> of the month).

Deathbed Marriage Registrations: As with above, there is no spike or increase in trend. Note that the figures represent licenses issued, but it is not recorded how many will have actually been used as often the individual may have passed way before the ceremony could take place.

PRAU are working with GRO colleagues to include daily updates on registrations and comparisons to service standards.
