Subject: REQUEST FOR INFORMATION ASAP 14/02/20 Social care/NHS interface - RWCS planning

Dear Keith

SoS is, entirely appropriately, becoming very focused on the ASC planning in RWCS – you may remember/be aware this was a significant weak interface when we exercised Operation Cygnus. I have been asked to support the discussions, offering both a clinical perspective and a public health and LRF system perspective. You will see this email is copied to Nisha who is a GP (and psychiatrist) who we are lucky to have in CMO's team for a few weeks and she is going to help me.

I am very aware of the critical interdependencies between 'decanting' less ill patients from the acute sector out to community and social care systems (including potentially children) and can work on the LA interface but I do not have sight of any of the detailed planning I know you have been working on in NHSE.

I don't want to start from scratch – I suspect we could think through a framework of how it could work, including linking in to clinically ethical prioritisation approaches and the practicalities based on earlier pan flu and recent coronavirus work.

I am just advised of a relevant SoS meeting on Tuesday so need to move this quickly over the weekend
Are you able to share relevant documents, in confidence if necessary, or point me towards those whom I need to approach?

I have copied in Stephen because he always seems to know everything that is happening anywhere!

FYI we will be simultaneously checking out current advice etc to care homes which PHE have created or are planning to do so, which hopefully will help you and colleagues
