data. As such, COVID-19 point prevalence is highly likely to be lower than in the UK for countries which:

- Are rated low or moderate risk under the PHE analysis, and where PHE have high confidence in the data they provide;
- Have had an incidence rate of less than 20 per 100,000 population for the last two weeks; and
- Have had a death rate of less than 10 per 100,000 population for the last two weeks.

I'm extremely concerned about this. Spain is now being held to a much higher level of scrutiny and performance than other countries. If it is not added to the exemptions list, ministers will have to explain why not when it has an estimated point prevalence rate of 0.015 (compared to 0.33 when the decision not include was originally taken) - 0.015 is verging on Green. And there is visible action from the Spanish authorities to do whatever it takes to suppress outbreaks (compare and contrast with outbreaks in England). It won't matter how much ministers might justify it on health grounds, the Spanish Government will conclude it is entirely political; they won't forget; there is a real possibility they will never approve EU membership for an independent Scotland as a result.
