It is not known yet whether there have been any cases of BNs testing positive in Italy, however the British Embassy in Rome is reporting it is “highly likely” that some BNs are amongst the quarantined.

Japan (Diamond Princess cruise ship)

- UK National Focal Point (UKNFP) has received details of all these individuals and passed information of Hong Kong residents to Hong Kong NFP. In addition, Japan has reported “asymptomatic pathogen carriers” who are close contacts of confirmed cases.
- The UK evacuation flight arrived at Boscombe Down on 22 February, with 29 BNs, 1 British National (Overseas) and 2 Irish nationals on board, accompanied by 16 HMG contractors. All cruise ship passengers and 3 HMG contractors went into isolation. On 23 February, Japan advised 4 BNs had tested positive and were subsequently transferred from Arrowe Park to NHS High Consequence Infectious Disease (HCID) units. FCO in conjunction with PHE are seeking a seating plan to identify those most at risk and to manage situation. FCO liaising with the charter company to obtain this information.
- Remaining Diamond Princess passengers with a negative test result have been released. Border Force (BF) have reaffirmed the usual caveats regarding advanced passenger information (API), as well as full British national (BN) passenger information, should those released from quarantine seek to travel independently.
- The CMO has advised that individuals returning from the Diamond Princess to the UK via other routes should be placed in 14 days quarantine, from the day they leave the ship. All BNs aboard the Diamond Princess are on a watchlist and will be met at ports of entry.
- DHSC are in the process of agreeing a protocol with PHE and NHS England for Diamond Princess passengers who choose to return via commercial flights, especially regarding transport and their potential arrival in devolved administration airports.
- BF have developed operational protocols for managing asymptomatic and symptomatic passengers arriving from the Diamond Princess who are registered on the Warnings Index (WI), and symptomatic passengers who are repatriated or who return via their own means. The guidance can be adapted for all UK Ports of Entry and is in line with the latest assessment from the Secretary of State from DHSC.
