Timing

Urgent. DCMS has asked departments to return their bids by 10.00 Friday 17 April. We have advised this it is unlikely we will meet this deadline and that we expect to provide our bids to them early afternoon Friday 17 April. Therefore, your comments are requested by 12 noon.

Recommendation

That you (Home Secretary):

- **Agree** to the submission of the following bids:
 - Domestic Abuse (joint HO, MHCLG and MoJ) to provide £60m support for the next 3–6 months (paragraph 5a);
 - Vulnerable Children £9.75m (Paragraph 5b);

- Refugees and Asylum Seekers (Paragraph 5c);
- Adult Victims of Modern Slavery (Paragraph 5d).
- **Agree** to the following prioritisation of the bids:
 - Top priority: Domestic Abuse
 - Equal second priority: Vulnerable Children, Refugees and Asylum Seekers, Adult Victims of Modern Slavery
- **Note** other areas where we know OGDs are pursuing bids in which we have an interest in and **agree** that we should be ready to explicitly support given shared policy interests (paragraph 5);
