We have just come off the PHE IMT.

PHE have reported, through Yvonne Doyle MD, that work on the modelling to inform scenario planning, 'next stage guidance' including on containment strategy, has been accelerated and will commence today.

This follows a Prime Ministerial meeting last evening and planned COBRA meeting on Monday.

I have requested that DAs / PHW be involved from the outset – and this was approved.

We are therefore sending in an email of participants from Wales to PHE.

Dr Chris Williams will lead this for PHW and I have asked Chris to forward your email contact details to PHE, so that you can be involved (as available) also. We will keep you updated and I will discuss / update on this further at the PHW/WG daily call at 3pm.
