I spoke to Carys (at the beginning of the email chain), who says that the reason behind the query about mass gatherings is that the FM has asked the question as to why other countries have banned mass gatherings, and on what science the UK government is basing their decision not to ban mass gatherings. He has asked for some background briefing on these two elements of the same subject.

We discussed briefly, and you said that you could provide some background for the FM from the SAGE position on the science behind the UK decision, but why other countries have taken a different decision would require some investigation. This issue about mass gatherings keeps coming up, so Carys says she would be grateful for some background on this matter.
