





Two issues on schools if helpful: 1. Have checked with Jim at HPS and no outbreaks linked to community school hubs/nurseries/holiday camps, etc which have been running now for weeks. Worth confirming that with HPS again as that's an important dimension and makes reopening looks 'safe' as low as prevalence is low. 2.
