- The Technical Advisory Cell (TAC) which comprised of a team of Welsh Government civil servants, providing a secretariat, coordination of information and leadership function for the Technical Advisory Group (TAG).
- The Covid Intelligence Cell (CIC) which was a multi organisational group hosted by WG (civil servants, secretariat, public health specialists) that collaborated on COVID-19 epidemiological information and key-indicators.
- I provided COVID-19 related evidence statements for the Technical Advisory Group (TAG). TAG comprised of internal (civil servants) and external (non-civil servants) scientific and technical experts who provide independent

- science advice and guidance to the Welsh Government in response to COVID-19.
- I was also an observer of the Health Protection Advisory Group (HPAG) and UKHSA Alert level update (ALU) – these groups collaborated on timely COVID-19 epidemiological information for decision making.

I joined TAC in September 2020 and my key role was to consolidate the multiple sources of evidence on research and tracking of disease progression. This was to inform appropriate public health related datasets and analyses with additional evidence to support decision making. I collaborated with my colleagues within the TAC/TAG as well as with those in PHW (Public Health Wales), officials in Welsh Government (WG), National Health Service (NHS), United Kingdom Health Security Agency (UKHSA) as required.

One of the key advice documents that I coordinated was the COVID-19 Situational Report (CSR). The CSR was a report that contained COVID-19 timely information and epidemiological data in order to guide decision makers about potential interventions that may have been effective and proportionate in containing the pandemic. It provided analysis of the available data sources such as, summary of confirmed episodes, COVID-19 infection survey, variants of concern, weekly epidemiology for Wales, International COVID-19 update, hospital occupancy, school attendance in Wales. The CSR was presented and shared with members of the CIC as required. A list of the meetings attended can be provided upon request.

My main contribution was the coordination, analysis and presentation of the CSR data to CIC. The CSR offered a transparent method of sharing information and findings with the public on a frequent basis in order to promote awareness and improve public engagement. occupancy, WG school attendance, etc). My role involved consolidation of the numerous (UK and international) data sources into the CSR. Our internal TAC processes ensured Quality Assurance.
