## Career History

My current role and job title is:

Deputy Director of Health Protection and Screening Services, Public Health Wales January 2020 to May 2022

Between these dates, I held the following posts with Public Health Wales (PHW):

- 1 August 2016 to 30 November 2020 Deputy Director of Public Health
  Services/ Director of Integrated Health Protection. NB During this time, PHW
  implemented an organisational wide Covid-19 response, with revised
  management and governance arrangements. I was deployed into various
  roles within this structure including a liaison role with Welsh Government.
- 1 December 2020 31 May 2021 Interim Executive Director of Public

Health Services (Interim Strategic Director PHW Covid-19 response) • 1 June 2021 – May 2022 – Deputy Director of Health Protection and Screening Services.

I initially qualified and worked in environmental health. In 2003, I achieved registration with the UK Public Health Register and was employed by the National Public Health Service for Wales as a consultant in public health. I have subsequently held the positions of:

 October 2003 – July 2007: Consultant in Public Health, National Public Health Service for Wales

- July 2007 March 2010: Regional Director of Public Health/ Director of Health Improvement, National Public Health Service for Wales
- March 2010 July 2016: Executive Director of Public Health, Betsi Cadwaladr University Health Board

- a) When and how you became a participant
  - TAG (TAC)

At the end of January 2020, Public Health Wales implemented its organisational response to the emerging threat of Covid- 19. This included implementing an approach using the escalation levels of the organisations Emergency Plan. In this context, I was deployed from my substantive role to support the Executive Director of Public Health Services (Strategic Director Covid-19 response.) I was allocated an initial role of liaising with senior officials in the Health and Social Care division of Welsh Government and other key partner agencies. This included the Chief Medical Officer and the Chief Scientific Advisor. My role involved attending meetings and communicating information between Public Health Wales Incident Management team and Welsh Government divisions.

In this context, I engaged with the Chief Scientific Officer at Welsh Government during the initial establishment of engagement with SAGE and establishment of the / Technical Advisory Group (TAG) / Technical Advisory Cell (TAC) in Wales. Terms of Reference of TAG/TAC are available from Welsh Government upon request.

My role included identifying colleagues from PHW, who were subject matter experts, to engage with the Chief Scientific Adviser in relation to SAGE and TAC.

My first invitation to a TAC meeting was on Monday 2 March 2020. In the early meetings my role included ensuring that the Public Health Wales IMT was aware of

the main issues being discussed at SAGE and TAC (for example the Reasonable Worst Case Scenario projections) and for supporting PHW Incident Management Team (IMT), subject matter experts and partners to engage and respond.

I was <u>not</u> a named member of TAG/TAC see <u>Membership: Technical Advisory Cell |</u> GOV.WALES

However, in my liaison role, I was in receipt of emails from the Chief Scientific Advisor, and emails/information from Welsh Government TAC secretariat. This included having access to a secure shared folder of information used to support TAC (Objective Connect) which was established on 2 March 2020.

#### TAC Education subgroup

On 15 May 2020, I was approached by the TAC secretariat and asked to approve my name being made public as part of a TAC Education subgroup. I was initially named on this new group to ensure that PHW had a contact point. I advised that I had not yet attended any meetings and there were other conversations taking place with education colleagues. I acknowledged that PHW had membership of the subgroup and I advised TAC secretariat that I would be passing this to a subject matter expert, to ensure a single PHW point of contact. I therefore did not attend any meetings of this subgroup.

#### SAGE

In engaging with the Chief Scientific adviser, I was initially identified as a representative of PHW to be included in the SAGE distribution list for papers. I was not an invited or contributing attendee at SAGE. Once colleagues had been identified, I facilitated the PHW subject matter experts to undertake an observer role at SAGE e.g. attending meetings via telephone as observers.

However, in my role, I received emails from <a href="mailto:sage@go-science.gov.uk">sage@go-science.gov.uk</a>, containing an agenda and papers for meetings. I received these emails from: SAGE 11 (28 February 2020) to SAGE 34 (7 May 2020).

NB On the establishment of TAC on 2 March 2020, SAGE papers were stored on a secure sharepoint site (Objective Connect) Objective Connect, to which all TAC members were given access to view.

I was not an invited attendee for SAGE meetings and with the agreement of the Chief Scientific Adviser, I was removed from the SAGE circulation list for papers on the 10 May 2020.

# b) The number of meetings you attended, and your contributions to those

## meetings:

#### TAG/TAC

I was not a contributing attendee to TAG/TAC. However, in my liaison role, I attended some TAC meetings in the early stages of the response, as an observer. Dates when I attended and recorded in my personal notes include:

2 March 2020; 23 March 2020, 2 April 2020; 8 April 2020; 10 April 2020; 6 May 2020; 11 May 2020

# **SAGE**

I was not an invited or contributing attendee at SAGE.

c. Your role in providing research, information and advice.

## TAG/TAC

I was not a contributing attendee on TAG/TAC e.g., as a subject matter expert and did not have a specific role in providing research, information or advice. In my liaison role, on some occasions, I shared information with the TAC co-ordinator and Chief Scientific Adviser to facilitate joint working with PHW.

#### **SAGE**

I was not an invited or contributing member of SAGE and had no role in providing research, information or advice.

I was not a contributing attendee of TAG or its related subgroups. In my liaison role, on some occasions, I shared information with the TAC co-ordinator and Chief Scientific Adviser, to facilitate joint working with Public Health Wales.

Public Health Wales was invited to and provided a number of subject matter experts to support TAG/TAC and its subgroups. The PHW representation of TAG/TAC, covered the relevant areas of Health Protection response, epidemiology and surveillance, microbiology/ virology (including testing and whole genome sequencing), health improvement and behavioural science.

# b) The way in which the groups were commissioned to work on the relevant issues

From my limited attendance at TAG/TAC and my support of PHW subject matter experts, I observed that commissioning of work of TAG/TAC was effective, noting that turnaround times for submission of information were often short.

## c) The resources and support that were available

PHW subject matter experts were adequately supported by the organisation to attend TAG/TAC.

## d) The advice given and/or recommendations that were made

As I am not a contributing member of TAG/TAC or SAGE, I do not feel able to answer this question

#### e) The extent to which the groups worked effectively together

From my limited attendance at TAG/TAC, and my liaison role, I observed that groups appeared to work effectively with each other.

# f) The extent to which applicable structures and policies were utilised and/or complied with and their effectiveness.

I am not clear on this question. However, from my limited attendance at TAG/TAC and in my liaison role, I observed that TAG/TAC meetings were structured and subject to processes and procedures for meetings and producing/sharing information.
