Yesterday you informed myself and the First Minister that having heard our concerns around the structure of the existing Executive response to the Covid-19 emergency that you propose bringing a draft Strategy for consideration by Ministers on Monday.

This is welcome and I thank you for your continuing efforts to provide the necessary support as Head of the Civil Service.

Our shared objective is to have a structure which is fit for purpose and which allows the collective Executive to contribute to saving lives and alleviating suffering of people affected by this escalating pandemic.

Failure to adapt will simply hamper our best efforts to respond.

In this context I write to offer some views which I would like you to take into consideration as you develop the new draft strategy.

I want the Executive and each Minister, through our shared leadership, collective responsibility and the diversity of our views, to be utilised and optimised through regular meetings where decisions are taken to respond to this emergency.

Everyone must have an understanding and input to the Executive coordination and readiness of this escalating emergency across all of government.

Communication is absolutely key.

Strengthened communication and more predictability around reporting on what is happening within DoH and across all departments is essential.

Everyone receiving as much detail as possible in a timely manner helps inform Ministers.

Therefore, direct discussions with the Minister, CMO and senior management team is critical and necessary.

I want to stress that this is not about constraining the Health leadership team.

Information and advice management, situational analysis, C3 civil coordination assessments, Sitrep and DoH/PHA daily surveillance reports will also help achieve this.

It is critical that Ministers have a full understanding of the Risks, impacts, and mitigation's in place.

We need to know what work is being done on critical incident/disaster horizon planning and who the senior responsible officer for this is.

The Minister for Finance has allocated almost half of the Covid-19 budget to DoH. The Health Minister will meet no resistance if gaps, needs or other investment areas are identified, including PPE, testing and ventilators where Minister Murphy is actively working to maximise procurement co-ordination between the two departments, North/South and East/West.

While we are a devolved administration I expect the Executive to have increased emphasis on our local / regional approach.

We must implement a widespread community testing & tracing programme.

As an island with two jurisdictions we must have a common approach across the island, including on modelling. There must be more regular North/South Ministerial meetings and I want to see the Memorandum of Understanding which has been devised, concluded and implemented with absolute urgency in the coming days.

The British and Irish governments are both members of the United Nations of which the World Health Organisation is located, therefore we should naturally be working with the WHO and international community.

The public information campaign which has now rolled out is very much welcome. This is good progress. I want us to appoint a director of strategic communications who is responsible for oversight and coordination, above and beyond what is being provided currently by EIS.

Communication with the public must be more than sufficient throughout this crisis using public health advice and guidance which is readily understood, including the behavioural change expected and statutory enforcement regime.

The civil response at community level to support people is vital. In order to strengthen our resilience we need to establish, without delay, a uniformed network of civil defence committees throughout the 11

Council areas, and give practical help and aid to every citizen, and protecting the most vulnerable through a multi-agency and community response.

Any Executive strategy has to be robust, but also agile, flexible and capable of adapting to changing circumstances as time and the pandemic moves into different stages.

I trust that this is helpful.

To all Approved Driving Instructors and Approved Motorcycle Instructors

The Coronavirus pandemic has been an unprecedented challenge, resulting in many changes to our way of life. In March, the difficult decision was taken to suspend most of Driver & Vehicle Agency (DVA) services in line with government guidance. The priority over the past three months has been to keep people safe. However, that decision has been a significant challenge for our customers, including Approved Driving Instructors (ADIs) and Approved Motorcycle Instructors (AMIs) in managing their businesses and supporting learner drivers.

As you are aware, whilst the DVA is responsible for regulating the ADI/AMI industry, it does not employ ADIs/AMIs in the capacity of delivering driving instruction and therefore has no remit to suspend your services for public health reasons or determine when you might return to work. I appreciate there remains some uncertainty about the date driving lessons can resume. It was wrongly reported that Driving Instructors could resume work from 6 July 2020 - for clarification, driving Instructors were not specifically mentioned in the list of businesses in the Regulations that were closed down due to COVID 19 therefore that is why I am advised they were also not listed within the close contact businesses to reopen from 6 July 2020 which was issued by the Executive Office. In preparation for re-starting, it may

be helpful to look through the training resources on the ADI National Joint Council website, which you can access through via the following link https://www.adinjc.org.uk/training-resources/

As we head into a period where the restrictions placed on all of us are beginning to change, we have been able to announce details on our plans for resuming services, including DVA driver services. I am also pleased to be able to confirm that Driver Theory Tests in Northern Ireland will resume from 6 July. I met earlier this week with NIAIC to listen to your concerns and gather feedback from the industry, which will help us develop new operating procedures and up to date guidance.

I will continue to provide you with specific details of our plans, including key dates and information on how we will manage our phased return to full service delivery. Practical driving tests for cars will be resumed as soon as possible but the priority must be that they can be provided safely for staff and customers and we will continue to be guided by PHA advice in this regard. Unfortunately, no date for resumption has yet been agreed. The DVA continues to work as quickly as possible to find a way forward that will keep you, your customers and staff safe.

I sincerely thank you for your continued support and I appreciate this has been a very worrying and difficult time for the industry. Please be assured I will continue to provide you with regular updates.
