CMO letter from HSE to schools to apologise to devalued admin re availability of tests - did not engage with DE. Intercepted some schools rec'd with no warning. Apology to schools in NI from HSE.

DASEA Capacity for contact tracing? Can it increase if required? Feedback not good. Capacity to test no of people requiring tests via contact tracing.

CMO School return - lot of pressure on testing system. Less than 1% positive - parents want to do right thing. Some pos tests in schools - lot of contacts per child. Setting up Public Health Team to look at approach to be used for children - similar to meningitis alerts - more targeted approach. 5000 tests last w/e - turn up lot of false positives. Will make up ground from

dip last week.

DOH Additional recent^m - return of universities.

DAERA Asymptomatic - still spreading virus?

CSA Small no of false positives - less than 1% - non-significant, but not recommended to be tested.

Asymp. - some have virus, some don't. False pos among those who don't. Caused problems. Can spread virus when asymptomatic.

APM % of testing done locally?

DOH Pillar 1 - 2000 tests, health care etc. - local NI
Pillar 2 - Randox, national - 4000 per day.
Can be accessed through online process.

APM Confident we have sufficient capacity. OK?

DOH Never OK, always pushing Pillar 1 - homes, health service.

National - mobile testing units.

DE Schools return - figures 93.6% pupil attendance. Last year 94+%.
Helpful - apology from GS, poor communications.

Working closely with CMO - dedicated phone line PHA.

Clear messaging to parents, schools
Large no of unnecessary tests -
liaise with schools - children in contact within 2 meters for 15 minutes. Focus on those who need tests.
