Yes, we can try, just need to firm up the question.

R value. I presume the fire break would be short of a full lock down. So I would think R would need to be about 0.9?

Length and number of fire break. Are we looking at a single break, with a 2 week implementation? And in another scenario a single break with a 3 week implementation?

Timing. Are we looking at the above 2 scenarios. Both either implemented Friday 16th or Friday 23rd Oct?

Evaluation. It would be useful to have an assumed baseline R comparison group. Given the increased awareness, perhaps a value around 1.2. We would also need some assumption of the level of transmission we return to after the fire break. Then we could evaluate, for example, the time 'bought' in terms of the time after the fire break it takes to return to some kind of amber warning level. Perhaps use the same value as the baseline.
