ICJU international comparators - Super spreader events and clusters (paper can be found in Objective connect as ICJU(20)028 - 20200619 - Superspreading Events and Clusters)

Key Insights:

It is highly likely that a minority of infected individuals are responsible for the majority of Covid-19 transmission, and likely that most transmission is driven by super-spreading events Some individual risk factors are biological, Others are behavioural

Key operational characteristics of a cluster targeting strategy are: prevention and detection focused on the contacts and activities most strongly linked to SSEs; and rapid response to identify and isolate the original source of infection through location-based testing and backward contact tracing

Facemasks and Super spreaders

Pro's

Super spreader events can't be predicted however it was suggested that if everyone wore a mask/cover then they would be prevented.

There is some evidence that the person wearing them is protected.

Some face covering wearing is better than none, and there is risk that the best becomes the enemy of the good in this narrative.

Con's

Incorrect wearing

Increased touching of faces - self-contamination

Incorrect removal and disposal of PPE – including an environmental impact

A false security that they may engender if used with people reducing their distancing and hand hygiene measures as a consequence

Mask fatigue where people do get fed up of wearing them and if they perceive that risk is low they will stop wearing them.

Cost implications for people least likely to afford them

A suggestion was made for a more proactive door to door testing practice, based on profiling based on country of origin, place of work, in order to predict and prevent. The antibody testing paper does suggested a more proactive approach.

There is growing support from TAC and TAG members for the use and of facemasks/coverings A suggestion was made to set up a task and finish group to support the recommendations to the CMO Action TAC to draft a consensus statement on facemasks/covering to include the mins of the previous TAG meeting. **RWCS for Wales** TAC are using different data sources including the SPI-M scenarios to produce a RWC for the long term for Wales rather than releasing new versions more frequently. Many HB's are using the RWCS as predictors. Clear comms needs to be reiterated that they ae scenarios Action RWCS for Wales as an agenda item at TAG on Friday 24 July meeting. May need to consider economic hardships, Brexit and impact on medical supplies etc. Rob and Fliss to draft a letter to SCG chairs and NHS planners on the availability of the RWCS Update from NR on the international report. Military's maps of high contact places in Wales that focussed on Education, **Industry and Tourism.** Most of Wales is now at risk. The greatest element now is tourism especially in West Wales which has remained unscathed up until now as now as caravan and campsites reopen and people coming in from areas where the rules are different and are forgetting the 2m rule. The long term effect needs consideration for the Universities especially in West Wales where they closed down early.
