But 4 issues where we need to crystallise our approach:

- 1. How to support vulnerable people, including children
- 2. Definition and application of 'key workers' in different contexts salience with the public re fairness of treatment
- 3. Social care generally capacity/workforce retention/PPE very important to generate a clear sense of cumulative effort to support the sector
- 4. Prisoner release- complex cross cutting issues and political risk.

And 2 issues that need more work:

- 1. Digital exclusion- many covid initiatives rely on digital access not available to most vulnerable how to mitigate
- 2. Possibility of redeploying Welsh Government staff to help wider effort outside government.

CG will be meeting officials to pursue these and update dashboard in light of discussions.

Actions: FM asked CG to focus on the first (vulnerable groups) as the most urgent priority, and the second, key workers. CG to take work forward on all of these issues as a priority over the next week.

#### **Domestic violence**

DMCW reported on work across government to respond to the increased risk posed to victims in lockdown situations.

Agreed approach was to revive the 'Don't be a bystander campaign', raising awareness amongst people who could offer support, including potentially pharmacies and supermarkets, as well as public services and volunteers.

An update letter would issue shortly to AMs, police, health authorities, local authorities and other partners.

DMCW also flagged the vulnerability of ethnic minority communities, gypsy and traveller communities and others.

#### Actions:

- MEERA to raise with supermarkets their potential contribution to the Don't Be a Bystander Campaign
- MHSS to pursue role of community pharmacies.
- Comms officials to consider how WG comms could contribute to messaging on DV
- Minority communities to be considered in the CG work on vulnerable groups.
