Rob, we have been advised that there is a lot of correspondence in that the 6 nations should be cancelled, large gatherings banned, schools closed etc. Is there a stock line that HSS correspondence and others can use in relation to why we are not doing this?

The UK Action Plan says this, but our correspondents are asking why this isn't being done now:

Action that would be considered could include population distancing strategies such as school closures and encouraging greater home working to slow the spread of the disease throughout the population.

Can we use the following line (or a version of it) from your briefing paper, or can you point us at some lines on this issue that have already been agreed? Correspondence unit is trying to head off as many of these as possible with a stock line.

Modelling evidence suggests that some interventions such as the restriction of mass gatherings (which includes closure of sporting fixtures, bars, restaurants, cinemas) whilst assumed to be effective, are not supported by evidence.

Rob – you must be getting a number of these too. Do you have a stock line?
