Several thousand displaced and recalcitrant (towards PRC) HK residents moving here would be a nightmare for them, and tricky for us given our desire to build relations with the 2nd largest economy. An ethical minefield.

The needs and abilities of HK "refugees" would be very different from the Syrian refugees.

A better parallel might be the Vietnamese boat people in the late 70s - that was not a happy experience and most of those people left NI for large towns in England.

There is an established Chinese community here some of which are HK. Ukg assess we are an attractive place. Not sure if the boat people had communities to settle with here. Would love to learn more about that. I think the politics of our aspirations towards China might shift a bit depending on how this plays out. Would be worth a no agenda, no papers think in?

Yes we should do that, I'll arrange. I'm not sure we should include Tim at this stage (to protect him).

Who should we in involve- just TEO at this stage? Or DfC and others as well?

The Boat people's problem was the lack of a local Vietnamese community (and they sent most of them to Craigavon ••)

Craigavon? Well .... as if the boat people hadn't been through enough.

Teo and DfC and justice I think. Not Tim as you say. And Anthony/Chris in case you need to invoke CCGNI on this. Just to scope. Other depts will need to be drawn in later. This could get big soon on diplomatic relationships and how people even get to leave HK.

And ukg will be in control so need a line into their thinking and arrangements. You'll need a docking in point on that with Leslie and Shan.

No, though do you not think it's largely semantics? The position they've all agreed is that you should be wearing coverings but it won't be legally enforced until 20 August.

Part of the problem is EIS issued the DoH PR in error. It shouldn't have gone out (cock up) and Chris has apologised to FM and dFM.

I think the difference is between commencement and enforcement. And doh need to draft regs. They did lean towards an enforcement approach today but that's not what we've been saying in public. Either way, face coverings are to be encouraged so it doesn't make a difference but it matters for the regs.

Yes, I've just seen your email to Chris.

I think the simplest thing would be for DoH to take the power on the understanding it will be commenced on 20 August if compliance is below 80% (which it will be). Get Robin to confirm this on Thursday and in the mean time ramp up the public messaging that we should all be wearing masks and, if we don't, we'll be compelled to do so in three weeks time.

Robin put in 1 August on the understanding it might get pushed back a bit. He was open to that being the outcome. Dup will be more comfortable with the commencement solution and I'm pretty sure they think that's what has been agreed

DFM and junior mins, cmo and CSA, me met last night. Some regs changes proposed. Reduce numbers in domestic settings, have the ability to set an upper limit on outdoor gatherings, reduce the threshold for a risk assessment for outdoor gatherings from 30 to 15. Separately, hospitality sector will propose some tightening which is a good and interesting development. Seeing some responsible steps and leadership from key sectors.

3/3. Mike tells me there's a growing sense that we are being driven by health advice. I've challenged that. I pointed to the facts: all proposed easements so far have been agreed. Only wet pubs, soft play and indoor sorts spectators have been paused in the context of growing case numbers. Social distancing 2 metres issue was against health advice. Face coverings delay was against health advice. Mike was concerned health might want a ni wide lock down. I assured him there is no desire for that anywhere in the system.
