1. The Executive agreed the minutes of the Executive meeting of 16 March 2021.

## COVID-19 Update

- The Minister of Health provided an update on, and the Executive discussed, matters relating to the COVID-19 pandemic, including hospital admissions; the position in care homes; the vaccination programme roll-out; and potential availability of the Moderna vaccine.
- 3. The Deputy Chief Scientific Adviser gave a presentation on statistical data relating to the pandemic, including the R number; positivity rates; testing capacity; and mobility trends.

## **Executive COVID Taskforce**

- 5. The Secretary to the Executive provided an update on the work of the Executive COVID Taskforce, advising that advice on a strong messaging campaign would be provided to the Executive ahead of the Easter break.
- 6. The Minister for the Economy requested that her concern be recorded that the length and complexity of the Executive's review process was threatening the continued existence of businesses already heavily impacted by the ongoing restrictions. She requested urgent consideration of papers which she had submitted to the Taskforce. The Minister also considered that the Executive needed to seek

- input from economists and those involved in community renewal to develop a wider and more inclusive process.
- 7. The Secretary to the Executive confirmed that amongst the expertise available to the ECT was that of the Chief Economists and advised that matters being raised by Departments and brought to the Taskforce for consideration were looked at in the context of a range of impacts across all sectors, the potential to impact on progress already made in lifting restrictions and possible unintended consequences / repercussions.
- 8. In response to the First Minister, she confirmed that the Taskforce was urgently reviewing the current restrictions applying to funerals, and other church services.
- 9. The Chief Medical Officer advised the Executive on the impact of new COVID variants, reiterating his view that a phased, cautious approach to easement of restrictions was the safest option.

## E (21) 073 (C) Limited Reopening of Sure Start and Youth Services

- 10. The deputy First Minister advised that this paper had been subject to the agreed Executive process for assessing relaxations proposed outside of the four-week consideration timeline.
- 11. The Minister of Education introduced this paper.
- 12. The deputy First Minister invited comment from the Minister of Justice, who welcomed the reopening of Youth Services, and advised of the need for a consistent approach to youth engagement in the run-up to the summer period.
- 13. The Executive agreed to the limited reopening of Sure Start and Youth Services as outlined in Executive Memorandum E (21) 073 (C) – Limited Reopening of Sure Start and Youth Services.

## E (21) 072 (C) International Travel - Executive COVID Taskforce (ECT) Update 4

14. The deputy First Minister introduced, and the Executive discussed, this paper.

#### 15. The Executive:

- (i) agreed that its approach should be based on the Red List, and that its content would be kept under regular review. The arrangements for managed isolation should be flexible enough to enable a broader approach on international travel to be put in place should the need arise;
- (ii) noted the update on the contract discussions and agreed the scope of the arrangements;
- (iii) agreed the designation of airports; and
- (iv) agreed how to manage the travel implications arising from the decision to remove the Stay Home requirement from 12 April.

16. The Minister for the Economy introduced this paper.


#### 17. The Executive:


