 The deputy First Minister advised, in the context of the planned publication of 'Moving Forward: Executive's Pathway out of Restrictions', of the need for a joined up Executive response to increasing social activity, including in the Belfast Holylands, over forthcoming holiday periods, and asked for all Departments with a role or interest to get involved in this issue, in cooperation with the Universities, Belfast City Council and PSNI.

- 2. The Secretary to the Executive introduced, and Ministers discussed, 'Moving Forward: The Executive's Pathway out of Restrictions' and the Executive Summary of the document.
- The deputy First Minister advised that following agreement, engagement on the document would be scheduled with all relevant sectors and that a Communications Strategy for publication was being developed by Executive Information Service.
- 4. Following discussion, the meeting was adjourned at 10.30 a.m. to enable officials to circulate a final version of the documents, taking account of agreed amendments.
- 5. The meeting reconvened at 12.40 p.m.
- 6. The deputy First Minister advised that an amended version of 'Moving Forward: The Executive's Pathway out of Restrictions' had been circulated for further consideration, which took into account the issues raised during the first part of the meeting.
- 7. The Minister of Justice advised that she had been contacted by members of the media, who had received copies of the document ahead of the reconvening of the meeting.
- 8. The Secretary to the Executive outlined, and the Executive agreed, the amendments which had been made to the document.
- 9. The Director of Communications outlined the Communications Strategy which had been developed to coincide with the First Minister's and deputy First Minister's statement to the Assembly that afternoon and publication of the document, and asked that all Ministers be available to take part in media activity as required.
- 10. The deputy First Minister advised that, following the meeting, the final version of 'Moving Forward: The Executive's Pathway out of Restrictions', as agreed by the

Executive, would be circulated to all Ministers, as well as a Question & Answer document which had been developed. The Secretary to the Executive confirmed that issues relating to international travel would be included in the Q&A document.

11. The Executive agreed to the publication of 'Moving Forward: The Executive's Pathway out of Restrictions', and to a statement being made to the Assembly.
