OFFICIAL SENSITIVE - CONTAINS UKG EMBARGOED INFORMATION

CDL called with FM and dFM, SG and WG at 11.30 today. JMs, Minister Swann and Dr McBride attended.

Main points on travel:

- Home Secretary will make an announcement in Parliament this afternoon
- Stronger messages on travelling abroad for holidays. This is illegal and action will be taken
- Review of exemptions, and bearing down on those who exploit the exemptions
- Requirement to isolate in hotels from variant hotspot areas

PM will announce that schools will not return before 8 March.

CDL noted:

- More details to be worked out on travel
- Need to look at CTA. SofSNI in touch with Irish Government
- Official level discussions later today with Irish Government
- Close working needed with DAs on messaging and enforcement

Simon Ridley noted:

- Next steps on travel, pulling together a programme of work and hope to dock in with DAs
- Review of travel exemptions will be taken forward quickly

Prof Whitty noted:

- Discussions ongoing with CMOs

FM SG:

- Press conference at 12.30 and significant speculation in the media. Will say it doesn't go far enough
- Such small numbers doesn't go far enough to suppress importation or guard against people arriving from South Africa via other countries
- Will consider if SG needs to go further
- Would prefer comprehensive supervised quarantine from other countries
- Need to learn from last year's experience

FM WG:

- Relatively small direct interest via Cardiff airport
- Entry via ports is largely CTA
- Advice to WG FM is that the UKG steps are not enough
- Variants unknown will not be captured
- Need to understand timings for new arrangements
- Need to understand enforcement arrangements
- Welcome discussions on a 5 nations approach

- Routes from South Africa and South America need to be understood. Need to look at Schipol in particular
- On education, is that for all of England?
- WG numbers are falling fast and priority is to get schools back. UKG announcement will have implications for industrial relations management with the teaching unions

FM:

- Very few direct flights to NI from the hotspots
- Concerned about arrivals in London and where people should quarantine. Need to understand this
- Welcome engagement with Irish Government. Welcome a 5 nations approach
- Continuing issue on the travel locator and data from Dublin. Need to resolve

dFM:

- Clarified that all people arriving from hot spot areas must quarantine unless exempt
- Welcome the two Islands approach
- Travel has never been appropriately resolved and this is the time to do that

Professor Whitty:

- Nothing to add, mainly policy points

Simon Ridley:

- Will work closely with Border Force on travelling through hubs. Ways to identify where people have travelled from and through
- Conversations with Irish Government important
- Will look at travel from London to NI and where people should self isolate
- Importance of increased genomic sequencing

CDL:

- Policy development will continue
- Looking for a coherent and secure approach
- Will reflect DA points in meetings this week
- Will take time to put the arrangements into place
- COVID O will prepare a timeline for actions which will be shared with DAs
- Ramping up messaging
- Aviation industry and hotels need to be ready. Discussions underway
- Each administration will have its own issues but a lot of common ground
- NIO will keep NIE informed of progress with Irish Government including on travel locator
- Hopeful that case numbers are falling. Vaccines will continue for the 4 top cohorts, aiming to complete 15 March – hence 8 March is the earliest date for schools to return

It looks likely that the 5.15 meeting today will go ahead, but to be confirmed
