# 1. WELCOME AND INTRODUCTIONS

# 2. COVID-19 - CURRENT SITUATION AND PROGNOSIS

 Richard Pengelly gave a brief update on the current situation - 209 confirmed cases at present. Hoping that addition information from Imperial College modelling on the spread and pathway in NI will be available by close tomorrow.

# PPE

- On PPE Richard said that stocks are holding up at present and that there is good coordination with CPD colleagues from DoF on procuring more urgently.
   DoH is ensuring there are sufficient supplies available across the care sector.
- There has been anxiety among staff and DoH have been communicating that we are following the WHO guidelines.
- Sue Gray said that CPD have a dedicated team working with DoH to procure more PPE, ventilators and hand sanitiser.
- PSNI said the situation was improving with supplies beginning to come in via DoF, but still remained a concern for them and a matter of anxiety for front line staff.
- NIAS said they were linked into the arrangements with DoH and the situation was improving, although like PSNI it still remained a concern for staff.
- NIFRS said they had concern about the supply of appropriate face masks.
   Was decided that NIFRS should be linked into the ongoing coordination between DoF and DoH.

# Action DoF: Ensure NIFRS are linked into ongoing DoH/CPD discussions on PPE.

- DFM asked whether a Judicial Review had been lodged on PPE. Neither DoH nor DSO aware of any Judicial Review on this matter at present.
- DFM said that it was important that staff concerns be addressed to build their confidence.
- Richard said that Air Lingus have switched to cargo flights from China for PPE etc. DoH and DoF have been working on securing a portion of the material imported.

# **Testing**

- Good progress is being made, with testing now increased to 600 per day and hoping to raise this to 1,100 daily by early next week.
- Public Health England ratifying locally produced testing kits, hope this work will be completed in next 48 hours. This kits can then be procured as part of the agreed 4 nations approach.
- Clinical led group working on the prioritisation of testing across the health and care sector.
- A piece of work was required to coordinate the need for testing across departments and emergency services. DoF agreed to undertake this work.

Action DoF: DoF to coordinate the need for testing across departments and the emergency services in conjunction with the NI Hub.

### 3. ACTIONS REVIEW

 Anthony Harbinson said that the action log was a work in progress and would issue to all members in advance of each meeting. He took the meeting through the actions arising at the meeting of 25 March.

# Agri-food sector walkouts

- Had been some walk out by staff at a small no. of agri-food companies e.g.
   Moy Park, over social distancing concerns.
- Mike Brennan said that revamped social distancing guidance had been sent to FM/DFM, this could be put into comms plan via NI Direct.

# Pay as you go Energy cards

 A problem has arisen over pay as you go energy cards. Electricity cards can be updated by mobile – but gas cards must be purchased in a shop. DfE speaking to gas companies.

# **Budgetary Matters**

• Some public companies are experiencing a lack of income which will lead to budgetary pressures, e.g. NI Water and Translink.

Action NI Hub: Sitrep update to be added to the agenda for future CCG meetings.

### 4. LEGISLATION OVERVIEW

- Chris Stewart gave an update on the Coronavirus Act which has now passed through Parliament. Focus now switches to putting subordinate legislation in place to provide clarity on enforcement etc.
- Very strong regulations have been drafted in England on powers to enforce closures and enforce social distancing. How best to put these in place in NI is being considered by TEO and DoH.
