Richard, Michael and colleagues

Please see the attached, which I trust you have already seen via health channels.

CCS policy advice is that similar provisions will be needed throughout the UK, and have asked for confirmation of the position by close of play today. Scottish colleagues are satisfied that existing powers are sufficient, Welsh colleagues are checking the position. Grateful for your advice on whether similar powers exist here, or if a similar set of regulations will be needed.

I understand that the attached English regulations are in force now. Chris M – I asked for media lines etc to be shared with us. CCS colleagues were unaware of the position in Ireland. Could I ask DoH colleagues to advise on that point please. An added sensitivity here would be the use of such powers on Irish citizens in NI.
