Introduction

New measures were announced by the Executive on 19th November detailing a pre-Christmas restriction event between 27th Nov - 11th Dec.

[NB the end date for these regulations has become ambiguous: either two weeks from 27 November (i.e. the end of 10 December) or 'until 11 December'. This has to be determined.]

These measures will need to be reflected in sealed regulations for the restriction period.

The objectives of this working group is to ensure that the announced measures and underlying intent is reflected in the regulations that come into force at 00:01 on 27th November.
