## Derek,

While fully respecting due process I would suggest that DSO considers challenging the appropriateness and proportionate nature of such an approach at this time. Normal judicial processes need to be considered as to their appropriateness at this time. Would a conversation with DoJ, AG and the Lord Chief Justice be warranted?

We simply do not have the time and this should not be our focus. This is a distraction. There are I would contend much more pressing matters in respect of human rights considerations and national efforts to protect human life.

While I would not wish to add to the already emotive language and narrative we are effectively on a "war footing." I would be confident that a robust argument could be presented to challenge this proceeding at this time.

There must be legislation and case law mechanism to consider and apply in the current circumstances.

Yesterday evening we received the attached pre-action letter from KRW Law threatening judicial review proceedings regarding the decision not to close schools in NI.

Caroline Martin shall deal with this case and has already been in touch with Junior Crown Counsel, Philip McAteer. Philip considers this is an issue of such importance that the Department may also want to instruct Senior Crown Counsel but we shall see.

KRW Law seek a response to their letter by 5pm tomorrow evening given the urgency. I believe the Court shall accept such a tight timeframe is reasonable in the circumstances.

Grateful if you could instruct one of your staff to gather together instructions for us tomorrow morning to enable us to reply to this letter.

Our office is not opening tomorrow (we have had one member of staff who has tested positive for coronavirus and the building is undergoing a deep clean) but we all have our laptops at home with us.

You will see from KRW's email below that they intend to ask the Court for an urgent hearing on Wednesday morning and shall have medical experts in attendance.
