Please could you pick up? SOS-FM/DFM | 25 November **Secretary of State First Minister** deputy First Minister Secretary of State opened discussions by asking about case numbers and asked whether there were any other COVID issues that FM/DFM would like to discuss. **DFM** confirmed that there were around 500 cases today. FM said that she would like to understand the UK Government's 'test and release' approach a little more as she previously understood that the NI CMO was not keen. She asked whether if someone came in on an international flight to London, would that 'test and release' policy apply if someone arrived in London and then moved to NI. **SOS** said he would ask for any data on this to be provided and will get further details on the London-NI travel aspect. **DFM** said that the main focus was around the 2 week circuit break and she said they were keen for the mass testing roll out to go ahead. SOS said that if there was anything in particular he could do to help push for NI, let him know. He said he had heard things were moving forward logically and that he was confident that it could hopefully roll out smoothly. Irrelevant & Sensitive
