The following comment has been made to your submission of 18/05/2020:

- i. I note that the proposed COVID-19 funding for Health is £323.7m;
- ii. I note that the funding held centrally for PPE has reduced from £150m to £83.8m;
- iii. I note that the £49m currently held centrally for Health is likely to represent the first instalment of funding;
- iv. I note that the COVID-19 funding recommended for Health does not fully meet the estimated requirements identified to date;
- v. I will advise the Executive, via Annex B, to consider the allocation of funding for Care Homes in the context of the paper to be brought to the Executive and in the context of funding currently being held centrally;
- vi. I note that a recommendation to provide health with £1.64m for reinstatement of strike pay has been included even though the Department has not sought this funding;
- vii. I will seek confirmation that the Department will receive the associated funding in respect of the Death in Service Payments in the context of the bid made in respect of Life Assurance; and
- viii. I agree to respond to the Minister of Finance as set out in Annex B, with a letter issued with an electronic signature.
