1. Chair Introduction/Welcome

Dr McBride welcomed everyone to the meeting.

2. Note of the last meeting

The minutes of the last meeting were agreed.

3. Matters Arising

Action Point 1: PHA to share presentation to PHA Board with Sponsor Branch and to engage with Sponsor Branch in taking forward the response to the review.

Dr McBride asked if the PHA wanted to quickly run through the presentation. Dr Bergin advised that work had commenced on a new planning model for Northern Ireland and both he and Mr Morton were engaging on the project board. He outlined that it is essential that the PHA is highly involved in this work, building on previous work on population health planning, but also ensuring that the PHA is central to the new planning processes and integrated care system prototypes.

Dr McBride thanked Dr Bergin for his presentation and noted that the approach he outlined could be built on the good work taken forward by the Making Life Better HSC Partnership on population health planning and the wider cross-government work underway as part of this key strategy.

Ms MacLeod stated that Dr Hussey's report had identified that much PHA work takes place in silos and that there is a need to work more corporately. Mr Morton suggested that, in linking the Hussey review to the work on the new planning model, thought needs to be given to the strategic role of the PHA.

New Action Point 1: The PHA continue to work with the Department, through CMO's office and the sponsor branch, to consider the Hussey report, the work on the new planning model and the way forward in the short, medium and long term.

4. COVID-19 Response I.

Contact Tracing

Service

Dr McBride advised that he had a useful meeting about the Contact Tracing Service. He noted that the Service should be very proud as it is performing strongly - CMO noted that he was aware of 2200 cases being dealt with in one day and he was hugely appreciative of the hard work.

II. Vaccination Programme

Flu Vaccination

The figures provided are helpful however there seems to be a very low occurrence of flu, although this may change. He asked if the PHA any issues to report? Ms MacLeod said that there were no issues to raise, and noted that they hoped to carry out an assessment to capture learning from this seasons programme later in the year.

Dr McBride noted the difference in this year's programme, with the use of large venues and drive-through facilities. He pointed to consideration needed in the uptake of care workers. Overall, there is work to do but the vaccination programme is heading in the right direction. A debrief later in the year to capture learning will be helpful.
