## Background

 I made you aware last Friday of the letter dated 31 July 2023 from the Covid Inquiry advising us that a Rule 9 would issue regarding informal communications between our former Ministers and Special Advisers as well as our senior officials. The letter asks for information regarding informal communications used by Minister, SpAds and senior officials in relation to the pandemic.

 I also advised you that some of the mobile devices allocated to our former Ministers and Special Advisers had been reset when Ministers left office to be ready for use by incoming Ministers and Special Advisers

## **Factual Summary**

- 3. Since then, we have been working to determine:
  - · What has happened across the system?
  - Which phones have no information on them.
  - · How each phone was handled.
  - Where there are gaps in the information we require.
- 4. DSO shared the letter form the Inquiry (with their permission) with legal teams for each department to determine the status of mobile devices across the NICS.
- 5. The table below summarises what we know at this stage. Further information is required.

## **Timeline**

  - 14 June 2021: letter from Darren Tierney, DG, Propriety and Ethics regarding record retention for the Covid-19 Independent Inquiry issued from HOCS to Permanent Secretaries, advising that the contents of the letter apply equally in the NICS
  - <u>25 June 2021</u>: Advise from Chris Stewart to TEO colleagues regarding retention of relevant documents, emails, text messages, etc.
  - <u>16 September 2021</u>: note from HOCS to Permanent Secretaries regarding Retention of Material including text messages and WhatsApp.
  - <u>17 September 2021</u>: correspondence from HOCS to permanent Secretaries dated 16 September 2021 issued from TEO Permanent Secretary to Grade 3s.
  - 11 March 2022: draft Terms of Reference published for consultation.
