### Proactive response

From Friday to Sunday police have conducted:

98 visits to support **Translink** premises  
92 visits to **Parks** and **Beauty Spots**  
391 visits to support **Retail** premises  
190 visits to **licensed premises** to support the licensing trade in addition to joint activity with Councils conducted by district licensing Colleagues

### **Reactive response**

From Friday to Sunday Police have received reports of:

55 licensed premises breaching the regulations  
5 reports in relation to retail premises breaching the regulations  
144 reports in relation to gatherings in private dwellings

### **Enforcement**

From Friday to Sunday police have issued:

125 fixed penalty tickets for a breach of regulations (**COV1 and COV4**)  
41 prohibition notices 41 at **private houses**, and 0 to **commercial premises (COV2)**  
2 fixed penalties for breaching the requirement to close a business or having a large gathering (COV5)  
122 Community Resolution Notices to individuals who breached the regulations.  
16 Arrests

### **Busy Period**

Overnight Saturday night was the busiest night with 77 reports of gatherings and 241 pieces of enforcement action taken. (Service day Statistics from 7am Saturday – 7am Sunday).

### **Some examples:**

#### ***Coagh – F District***

Police attended an address in Coagh following a report of a 40-50 people fighting at that location. On arrival police observed a number of carloads outside the property and a mass amount of people in the front of the property. One car made off driving dangerously and police suspect the driver was drunk. 40 or 50 people came from the property and started to run off into the fields. Police located a further 15-20 people inside the property including the 18th year old whose birthday it was and her two parents who reside in the house. The two parents have admitted organising the party for their daughters 18 birthday and supplying the marque and the alcohol.

The driver of the car was subsequently arrested and has been bailed pending further enquiries.

This resulted in:

1 x COV2 prohibition notice  
12 x COV4 £200 ticket  
5 x CRN (juveniles)  
2 x COV5 £1000 fine for the organiser.

#### **Belfast – A District**

Police attended a Belfast address following a report of a large number of people gathered at that location. There was a linked log that 20 people were fighting with each other in the street with hammers and glass bottles. On arrival police observed 34 people strewn between the two apartments which have been rented for the evening. The persons present were very un-cooperative and many refused to provide their details.

This is therefore classed as a mass gathering with more than 30 persons present and there has been new regulations put in place to deal with gatherings of this type so the organisers can receive heavier penalties

due to the elevated risk levels they are placing themselves/the persons present and the community in. This resulted in:


