**ISSUE:** Briefing for your weekly catch up with First Minister and deputy First Minister

**PRIVATE OFFICE COMMENTS:** Due to diaries, we couldn't get a Quad in this week. We are waiting for the Irish Government to confirm 5-6pm, Tuesday next week.

It may be useful to get their views on:

- 1. How the NI Executive publication has landed in NI.** You can be positive about the compatibility of the approaches and the criteria that both the UK Government and NI Executive have outlined for relaxing measures being largely similar. You could draw comparisons that both governments' criteria are based on scientific/medical advice, ensuring health and social care capacity and controlling the rate of infection.
- 2. The current NI Executive view on the border measures.** It would be good to understand where the Executive currently is on this. The GPS meeting today was cancelled where the measures were due to be discussed in order to allow time for further discussions on finalising the papers - you can explain this to them.

To note, CDL sent a letter on Wednesday evening to all DAs setting out the rule changes regarding how the people of Northern Ireland can bring family members to the UK. I&S

## **FIRST MINISTER, DEPUTY FIRST MINISTER MEETING WITH SoS - 15/5/20**

### **STEER**

Important opportunity to set out latest plans on lockdown easements, to promote continued close-working on tools (such as Track and Trace) where there is a dependency on respective policies (contact tracing) and encouraging clear communication as we all build up to the decision-points on lockdown easements. Given the divergence it remains vital to minimise the risk of confusion or concern amongst the public. The Executive agreed a range of relaxations last night to be implemented quickly, you may wish to ask them for an update.

You may also wish to update them on the latest plans on the borders measures announced by the PM last week. They may raise the family migration rules changes announced by Home Office yesterday - lines are below if needed.

### **SPEAKING POINTS**

#### *COVID-19*

- Welcome meeting again - it is a good opportunity to discuss our current priorities in the response to Covid-19 and exchange information;

#### *Approach to Easing Lockdown/review of public health measures*

- Northern Ireland: Welcome the NI Executive document (Coronavirus Executive Approach to Decision Making) setting out its five-stage plan for easing the Covid-19 lockdown which will be 'conditions-based', alongside the NI regulations being reviewed every 3 weeks.
- Welcome the announcement to relax a number of Northern Ireland's lockdown restrictions including the reopening of garden centres and recycling centres from Monday. Appreciate a further update on overall strategy, as well as any potential progression of the plan prior to 28 May?
- Welcome an update on North/South discussions and whether there are structures in place to share information on decisions on lockdown easements;
- Really important we continue to talk as our plans evolve - recognise what you said about NI being at its own stage of the outbreak and I'm keen to work with you to give you what you need from UKG

#### *NHS Covid-19 app - if raised*

- Important that we continue to work together to raise the importance of the NHS app being interoperable with the Irish Government's app, and to solve the technological issues. I understand there is a meeting today [Friday] between our Health officials and those in Ireland to discuss the latest work.



### *UK Borders announcement*

- As the UKG set out on 10 May, those arriving in the UK from overseas will be required to self-isolate in order to prevent re-infection from abroad and a second wave of cases.
- CTA routes will be exempt, which is a great result for NI.
- Understand there will be a further GPS MIG discussion early next week.
- The plan is still for England to introduce regulations early next week - your officials are invited to the working groups for these regulations and other implementation issues - like enforcement.
- Understand you are due to receive/or have received advice on this to formally consider the policy and agree whether NI will implement its own regulations - really keen we have a four nations approach on this, so really grateful for your support in rapidly considering the advice and any issues.
- I can work with you to resolve any specific concerns you have so the policy we adopt works for all four nations.

### *Inclusion of France - if raised:*

- No quarantine measures apply to France at this stage and we will be working together with the French on this issue in the coming weeks. As was said in the PM's speech, "co-operation is particularly necessary for the management of our common border" - but there are no current plans for a whole country exemption as some have reported.
