Hi all,

In advance of a longer readout, I wanted to share these actions with you from a call that CDL had with the DA FMs, as they are relevant to you.

**UKG** to share tiering principles and specific toolkit in due course.

**CDL PO** to work with No10 to set up COBR as early as possible early next week. **NB: SG AND WG PUSHED HARD FOR SUNDAY, AND MONDAY AT THE VERY LATEST, AND COULD NOT CONFIRM THEY WOULD NOT TAKE DECISIONS BEFORE A MEETING WAS CONVENED.**

**CDL PO** to work with COVID Taskforce to establish DA-appropriate COVID-O meetings and give as much advance notice as possible of these.

**COVID TF** to work with HMT to confirm Barnett consequentials ASAP to DAs, and clarify how they will account for the demand-led payment.

**CDL PO** to work with HMT to provide direction of travel to the DAs on economic support to businesses.

**CDL PO** to make sure No10 responds to DAs' concerns about aerospace industry ASAP.

**No10** to share aerospace letter with CDL PO.

SG and WG both mentioned possibly imminent decisions on new measures. WG said one of theirs might be 'stay local' messaging. **COVID TF** and **UKGG** and **TOs** to ask **DA officials** to share information on their thinking.

Officials will follow up with yours.
