Not Likely	Negligible additional impact above “normal” seasonal issues	Green
Likely	Short term inconvenience or disruption to services which is manageable	Amber/Green
Medium	Business placed under pressure or at risk, intervention required to prevent economic damage in the longer term. Risk of disorder or disruption to normal way of life.	Amber
High	Loss of multiple businesses, medium term damage to sector, realistic risk to life or public safety.	Red/Amber
Very High	Very serious impact, loss of significant business or significant damage to an entire sector. Significant risk to life or public safety.	Red
