 - (ii) noted that this did not change the situation for indoor home visits, pubs and restaurants, or hotel conventions.
- 10. It was agreed that messaging to reinforce the continuing need for social distancing and other health protection measures would be reiterated during media activity following the Executive meeting.
- 11. Junior Minister Lyons requested that that clarification of the legal position of driving instructors engaging in business be provided. The Minister for Infrastructure advised that engagement was ongoing with Trade Unions in relation to guidance for a resumption of driving tests.
- 12. It was agreed that further mitigations advice in relation to outdoor events should be provided for consideration at the Executive meeting of 2 July.
