Face coverings

We recommend the use of cloth face coverings (mouth and nose) for short periods of time when members of the public are in enclosed spaces where social distancing cannot be maintained. Examples of such locations would include public transport and some shops. Evidence is not strong enough at present to recommend the use of cloth face coverings outdoors or for prolonged wear in enclosed spaces.
