INVITE TO: DRAFT CONSOLIDATED COVID RECOVERY PLAN – PARTICIPATORY STAKEHOLDER VIEWS

You are being invited to provide your expert views from across society on the draft Consolidated Covid Recovery Plan.

The Covid-19 pandemic has significantly impacted all aspects of our society. Government Departments have been focusing on developing recovery plans, as they begin transition from crisis mode to short term recovery considerations, with some significant work already delivered.

The Executive Office has worked with Departments to develop a draft Recovery Plan for Northern Ireland to deliver societal, economic and health recovery and to inform the Executive of the priorities for the Government with regards to accelerating recovery.

The draft Plan provides opportunities for collaborative action intended to:

- Accelerate recovery over the next 24 months;
- Ensure the citizen is better off in the short term; and;
- Address critical challenges our citizens are facing today and in the near-term.

In developing the Plan, emphasis has been on cross-cutting priorities to accelerate recovery across four main areas over 24 months:

- Economic Growth;
- · Tackling Inequalities;
- Health of the Population; and
- Green Growth and Sustainability.

The purpose of the Recovery Plan will be to accelerate recovery from the Covid-19 pandemic in the short term so we can emerge stronger and also to transform and to seed longer term innovative ambitions. We see recovery not about getting back to where we were before, rather it provides the foundation for economic, health and societal renewal.

The draft Recovery Plan attached at Annex A focuses on the delivery of 85 interventions over a 24 month period. (This is a draft Recovery Plan and is subject to policy development. You must not share this outside your organisation).

You are asked to consider the draft Recovery Plan and provide views on behalf of your organisation by answering a series of questions, using an online platform the link for which is provided below.
