- Considering the restrictions proposed by the hospitality sector, earlier closing times and withdrawing entertainment licenses. Task and finish group meets today to discuss (I'll circulate the action plan next)
- PSNI are asking for additional powers. I'll circulate that next
- Changes to regulations today, as agreed at the Exec last week. Smaller numbers in domestic settings, lowering the threshold for risk assessments for gatherings, sliding scale of upper limits on outdoor gatherings
- Work also needed on the offence of organising a gathering. Need to make organisers more culpable than attendees, and need a bigger fine
- Some guidance relevant to hospitality will be underpinned in the regs so it has more bite. A video of a wedding is doing the rounds. I'll forward.

Karen,

PHA colleagues in Health Protection and the Contract Tracing Service need to assess tomorrow morning. A significant number of the cases in MEA probably associated with the plant, some further work is required to fully determine the chains of infection.

The contact tracing service and Heath Protection team has been very busy over the weekend and will need some time tomorrow to work through the data and get the overall position. PHA and my DOH colleagues and myself will consider the data, intelligence, implications and consider and advise on appropriate action.

What is also clear is that there is widespread flouting of guidance by many bars and pubs:.alcohol only been served, food receipts issues when no food served; food placed in centre of tables on display; queuing at bars; singing etc. I was in contact with Alan Todd over the weekend such were my concerns. We need to take firm enforcement action through fines and closures. Such behaviour by some in the sector is high risk and damaging to the reputation and standing of others. If the sector doesn't get its house in order immediately i will be advising that it is closed down

A priority and focus for TEO and Executive I would suggest would be strengthening of enforcement and messaging of existing guidance end regulations as discussed last week. My sense is that too may are simply paying lip service or ignoring.
