- Running on minimal numbers;
- Implementing social isolation advice;
- Intend to work in cellular offices;
- Need to comply with NICS policies and procedures.

## 3 key areas:

- (i) Planning
- (ii) Operating response
- (iii) Innovation problem solving within security environment
- -EY have a team ready to step in.
- -CVs and bios ready to be sent in with a view to starting tomorrow.
- -EY to send in for TEO consideration

AH – advised that he is also working with PwC, Deloitte and others eg KPMG.

He explained that given this is the most critical national emergency of time all contributing to national response.

Anthony explained as this virus impacts on wider society then it requires a flexible and agile approach.

Andrew Foreman and NR - CD advised -very senior people who can provide strong leadership in a pressurised situation.

AH suggested getting all key people in a room to identify the different requirements and allocate tasks.

AH – need to manage with a sense of calmness and urgency.

AH – asked the consultants to liaise together and work out a pragmatic approach.

It was recognised that contractual arrangements will be required but we all need to work together in the national interest.

AH – advised we have enough people to get the Hub up and running in the morning.
