CST was just on a call with [NR] in No. 10 and promised her two things:

- The table highlighted below, setting out levels of supply before/after HMT approval. Wants to show Munira how low DHSC let supplies go before coming to us for information and how little information DHSC have been giving us. I know you're already working on this – can I check in on how long this will take to produce so I can manage expectations?
- A table that sets out all of our procurement approvals so far for DHSC – setting out the key numbers bought, cost etc. for PPE, ventilators and so on. Munira was interested in the country that we were procuring these items from (I think linked to the case in Spain where test kits have had to be recalled). Philippa, I think you were already pulling this together – is it something we possibly have on the stocks? I think if we can get this to [NR] tonight or first thing Monday then that can buy us a bit more time on the first table.
