They currently have a number of products in TA, one of which in closing and I have suggested a RR be stood up as it is for goggles NR are trying to set up a RRT to deal with this.

I will be placing all of my folders in the hand over file in teams tomorrow so there will be full traceability of what they have offered, Mendix will also be up to date with my notes. I will not unlock their account until tomorrow and when I do I will let you know so you can jump in and assign them to yourself.
